

GENERAL MEETINGS 1980 08/17/80

August 17, 1980

The annual meeting of the Church Pine, Round & Big Lake Protection & Rehabilitation District was held Sunday, Aug. 17, 1980 in the Alden Town Hall at 2 P.M.

The meeting was called to order promptly by the president, Don Jhuke.

The minutes of the previous annual meeting were read by the secretary and accepted. The officers and committee members were introduced. The treasurer was absent because of illness.

The treasurer's report was read showing receipts from tapes of \$1,799.43 - expenses \$192.80 - interest on savings \$250.37. Balance on hand in checkbook \$264.98, and savings \$5,082.09.

The report was approved as read.

The business of the day was postponed until later so that our guest speakers could present their information first.

The first speaker was Wayne Lundberg from Aquatic Nuisance Control and a resident of Lake Hopagasset, who explained about the chemical treatment of weeds and the cost of \$1.20 a running foot 80 feet wide for use by any individual concerned.

The next speaker was (Uldis) Erdmanis - a (Uldis) civil engineer &

member of Mateffy Engineering, a sewer and sanitary planner, who explained what procedures had to be undergone to establish a sanitary district and its benefits.

The next speaker was George Moeller, a resident of Cedar Lake who told us about the lake study and results ~~of~~ or lack of results and their decision to initiate a sanitary district.

The last speaker was Alt Brosveen from Bone Lake who also told us of their lake study and results and findings.

Each of the men were qualified to speak in their respective fields and many questions were asked by our members in attendance.

The letter regarding the ~~Association~~ newly formed Wisconsin Association of Lake Districts and its by-laws was tabled until a later date and after the November referendum after it was read and explained by both the president and Geo. Voller with their opinions voiced on the matter.

Bill Berke told of the contents of the letter written to the DNR regarding walleye planting and read their reply.

Nominations for two Commissioners were taken. Don Johnke's term of office expires. (2)

A three year term was won by Kenneth Peterson from Church Pine by a 31 to 7 vote. The one year term to fill the unexpired term of Sheldon Weiss was won by unanimous ballot by Richard Larson from Big Lake. Ken Peterson is the new president for 3 years. Janne Berke is the current secretary - 2 years. Richard Larson, the treasurer for one year. Old business. Discussion on putting dye in the septic systems ~~was~~ initiated but found it was very difficult to undertake. A motion was made & seconded <sup>& approved</sup> to set up a commission to inquire into a sanitary system. A motion was made & seconded & approved to have said commission petition the town board for Sanitary District Powers under Chapter 33. Motion made & seconded to adjourn.
