\* Sheila Springer <sup>presented</sup> gave the weed-cutting report. None of the volunteers from Chequpine showed up to monitor weed cutting. Sheila accepted the

Questions + comments were fielded:

- C ① Did they cut between Round and Chuckpine? Yes, it's deep water + the machine kinda runs over the weeds, only cuts the tops.
- C ② Weeds appeared to be ripped out, not cut.
- ③ Can we get them to cut the weeds before they bud? No, it's too early and the weeds aren't tall enough. There aren't many weeks around for us to switch dates.
- ④ Do we have Eurasian milfoil? Can it be eliminated? No, we don't have it, + it can be dealt with once known about. The closer lake to us that has it is White Bear. Green Lake in Chicago Co. also has it.

Discussion was held as to next year's budget for cutting. Sheila recommended that the channels be cut, + property owners individually contract to have their shoreline + docks cut. But if not enough people contract, Aqua Care may not come in. Will get the name + phone number, to call in the spring newsletter. Private cutting will cost \$1.25 - \$1.35 foot.

Chairman Jannke opened the floor for discussion of next year's budget. There is erosion at the dam + correcting it could be a <sup>big</sup> problem; we need to have surplus available for that. Discussion brought up the channel between Round + Big Lake - a new + improved version would cost between \$7 + \$10,000. The budget is

10' wide, channel should be 30' wide,  
3'-4' deep, & we'd have to use rock per  
DNR. Water level is higher this year -  
if your pontoon is too tall to get through,  
cut the console down. Work on the channel  
will be tabbed for now.

MM Dick Larson to budget \$13,000 for  
1991-1992 budget. 2<sup>nd</sup> by D.V. Peetier.  
Motion carried.

Church rental is up to \$35. MM Carolyn
