- -Snails noted on Church Pine this summer-this is cyclical.
- -The Horse Creek Water Shed Planning group is trying to reduce the phosphorus going into Cedar Lake, The are looking at farmyards and well closings.
- -Ron Scorn talked about the watershed.
- -Brook Whalen-Polk County Rep. for Water and Resources has a web site for information.

Regarding phosphorus- 1 ton of dairy manure creates 3# phosphorus

1 40# bag of 10-10-10 lawn fertilizer= 5#

1# phosphorus will crate 500# algae

Fertilizer has a dramatic impact.

Dick Palen-member-questions the value of weed cutting vs. chemical weed treatment.

Dick Rudolph-1. Cutting is temporary

2. Herbicide-has effects the DNR would not care for on our lakes. Little if any effect with chemicals.

3.Lime Slurry-best

The clearer the lake the more the weeds due to the sunshine causing more plant growth. A major deterrent is a heavy snowfall to block the sun.

John Schulte-When Purple Loosestrife is in full bloom one must get after it.

Beetles-cage over the plant with net. Put inside the beetles from Germany. They affect only this plant. When loose strife is gone they are off.

May also cut it and brush on Round Up.
