The Church Pine, Round and Big Lake Protection and Rehabilitation District Annual Members Informational Meeting

Sat. May 17, 2008 9:30 am Immanuel Lutheran Church

The meeting was called to order at 9:40am with the introduction of the Board. First speakers were Frank Kashere, Northern Region Plant Management Consultant and Mark Sandeen, Aquatic Manager, tel 715-392-0807). Their report:

- 1) Recommended we update our aquatic survey (our last one is 7-8 years old done by Barr Engineering)
- 2) We need a more realistic assessment and can achieve that by hiring a consultant to develop APM Plan and get permits DNR has increased funding for invasive species identification/eradication by \$5,000,000 so there is more money available than previous years..
- 3) We should apply for "Lake Planning Control" Grant and "AIS" Grant (Key to gaining grant money is to stay hands on involved as a District with "clean water, clean boats," programs such as boat landing inspections or if there are new invasive species problems: i.e., Hydrilla see sample Control Plan UW Website).
- 4) We are most likely to be approved for lake wide mechanical cutting or herbicide weed removal based on the following:
 - Navigation problems vs. navigation inconveniences)
 - Protect native plants vs. remove native plants
 - Aesthetics such as "algae bloom, pea soup" not usually considered, but rather focus on protecting native plants protect:
- 5) No permit is required to remove weeds in front of lot if following conditions are met:
 - 30' wide as far from shore as desired
 - Must be manual (not motorized)
 - Can be hired out
- 6) Plant survey \$40K-\$120K Annual Plant Management Grant: 25% we pay/75% state pays
 - Staff to help: Pamela Toshner and Joan Hiscke
 - \$5 million/annually
 - Aug.1st and Feb.1st deadlines
 - Macro survey due by 08/01/08
 - Recommend we hire Cheryl Clemmons
 - Grid based plant study using GPS vs. line survey.

Art Gamache requested feedback regarding a proposed "short term lake home rentals" amendment by the Land Information Committee to the Shorland ordinance. A Motion to not approve lessening restrictions was made by Diane Marten which Jill Paulson seconded motion and it passed by verbal vote.

Boat Patrol Report by Office John DeBois - Patrol will work in 4 hour shifts for a total of 250 total hours Fri/Sat/Sun and Holidays. The citations and tickets will be processed through the Circuit Court. Patrol Phone number is 715-284-3628.

Rick Thomson, Midwest Weed Harvesting Report – 763-238-1012. His company recommends mechanical harvesting which is effective alternative to herbicide and they will give us a bid when ready.

Jerry Schlagel gave Treasury/Budget details and reported that audit had been completed.

Tim Formo Report – Clean Boats, Clean Water – signed up volunteers to work at Boat Landings and take weed samples.

Mary Hazzard Report – website update and statistics, appeal to volunteers for Board and Committees, email list, Fishing Contest

- 1. To replace the patrol boat and/or motor
- 2. Fish stocking

The Special meeting called to order at 8:05 a.m. Introduction of Board Members including Merle Paulson, Mary Hazzard, Tim Formo, Nate Wendt, Jerry Schlagel, Helen Johnson – Parliamentarian, and Art Gamache – Polk County

Agenda:

#1 Patrol Boat – current condition: 1982 era motor and boat leaks. Tilt and trim doesn't work. DNR pays 71.4% for the biennial and we can write the purchase off over 5 years.

Jerry Schlagel passed out several price quotes for various combinations including: Motor only/Boat and motor only from Sunnyside Marina and Warmers Dock.

Motion made by Dick Larson and Seconded by Jill Paulson to spend up to \$12,000 limit on motor, boat & trailer. Discussion took place and a new motion was made by Dick Larson, Seconded by Steve Paulson, to increase the upper spending limit to \$17K. A suggestion was made to scrap out the old aluminum boat. Voted by show of hands 23 in favor, 1 opposed. Also a 5 person ad hoc committee was formed to research boats and motors including: Jerry Schlagel, Tim Formo, Tom Diaz, Dave Zanick, Steve Paulson.

#2 Fish Stocking report given by Nate Wendt: If District wants to raise our own fish, which would reduce the cost by about 50%, it takes two years to get permit and the Permit cost is \$500. If we purchase, the current price is \$1.70 per walleye fingerling. A Motion made by Steve Paulson, Seconded by Brent Martin, to match Big Store \$2600 donation for a total of \$5200 for walleye stocking in 2008. Motion passed unanimously.

Tom Diaz motioned to adjourn, Steve Paulson seconded, and Motion passed to adjourn at 8:45 am.

Agenda

- 1. Introduction of Board Members including: Merle Paulson, Mary Hazzard, Tim Formo, Nate Wendt, Jerry Schlagel, Helen Johnson Town of Garfield (who acted as our Parliamentarian) and Art Gamache Polk County Merle gave a synopsis of the just finished special meeting for new arrivals.
- 2. May 2008 Member Meeting Minutes were read. Tom Diaz made motion to accept, Steve Paulson Seconded and they were approved by voice vote.
- 3. Treasurer's report was given by Jerry Schlagel. Tom Diaz made motion to accept, Steve Paulson Seconded and it was approved by voice vote.
- 4. Budget 2009 budget line-by-line explanation including the following:
 - Weed survey to be done by Steve Shafer in June and August 2009 using a GPS Grid to ensure surveying of major bloom of the Curly leaf pond (which dies off by early July) and other species
 - Purple loosestrife, a major problem on Big Lake, can be removed without DNR approval and should be removed right away as it is currently in bloom and easily recognized.
 - A Motion was made by Tom Diaz, Seconded by Steve Paulson, to add \$5K to weed control in 2009 budget. Motion was passed unanimously. A Motion made by Tom Diaz, Seconded by Rob Starbuck, approved unanimously to add \$5000 for a total of \$26,000 levy (vs. \$21,000) (revised 2009 budget)
