August 23, 2014

Board members present: Gary Ovick, Ann Layton, Mike Reiter, Helen Johnson, Steve Oswald, and John Bonneprise.

Call to Order: 9:04 a.m. Gary Ovick explained the function of a "District".

Secretary's Report: Minutes for A24, 2013 were presented. A motion to approve the Meeting minutes was given by Wegele, seconded by Dick Larson. Discussion: Bob Meyer stated that he felt the By-Laws were not legally removed from the District's Laws due to there not being a 2/3 vote for ratification. The motion carried.

Treasurer's Report: Gary Ovick presented for Jerry Tack.

Audit Report: Gary Ovick presented for Joel Hazzard.

Grant Status Report: Gary Ovick presented.

COMMITTEE REPORTS:

Aquatic Plant Management Committee Report: Mike Reiter presented.

Clean Boats Clean Water Committee Report: Ann Layton presented.

Fish Stocking Committee Report: Bob Meyer presented. Bob stated that nobody knows exact survival rates, however, fishermen have had success catching stocked species. Bob stated that the DNR has approved our Program.

Navigation Committee Report: Ann Layton presented. The no wake zone on Church Pine had been extended to help long term.

Social Committee Report: David Zanick presented. The 4th of July parade was a success with 40 boats attending. The Social Dinner was considered being moved to the Annual Meeting evening.

Water Patrol Committee Report: Gary Ovick presented for Tom Bach. Our new Deputy is Matt Throngard. The Patrol Boat was paid off in 2013.

Water Quality Committee Report: David Zanick presented. Sampling of wells for phosphorous was done. Results are pending. The District will apply for a grant to study in-lake phosphorous. This will be deemed the "Healthy Lakes Implementation Plan" and will be zoned the following: Zone 1: Water. Fish Sticks. Zone 2: High Water mark up to 35 feet of shoreline. Zone 3: Above the 35 feet mark; Rain Gardens, French Drains, Rock Infiltration Pits, Runoff Control. Up to \$1,000. will be paid by the DNR or 75% of the approved project up to \$1,000. The EPA has placed Big Lake on a proposed "Impaired Lakes" list. If this proposed list is accepted, the District has a better chance of securing this Grant. The EPA has Federal (Impaired Waters Grant) funds for Grants if the "Impaired Lakes" status is obtained.

Web Site Committee Report: Jeri Diaz presented.

2015 Budget Proposal: Gary Ovick presented. There has been no Levy increase in 3 years. (1) Grant ends, (2) Grants begin. A new boat will be purchased in 2015. This boat will be purchased outright as the funds are allocated. Steve Paulson motioned to approve the Budget, Tom Diaz seconded. Discussion: The question arose as to why a new boat? It made good financial sense – Trade in is good, money is in account. Motion carried unanimously. Budget Approved.

ELECTION: Gary Ovick presented the Board's nominees: Jerry Tack (up for re-election), and Beth Hartman, (replacing Steve Oswald). Also a write in candidate was available on the ballot. Jerry Tack received 28 votes, and Beth Hartman received 29 votes. Both were elected to a three year term.

Closing Remarks: Gary Ovick presented. 10 % of the Lakes Owners are represented at the Annual Meeting – please pass the information packets out to your neighbors. A motion to adjourn was made by David Zanick, and seconded by Ann Layton. Meeting Adjourned at 11:27 a.m. (?)

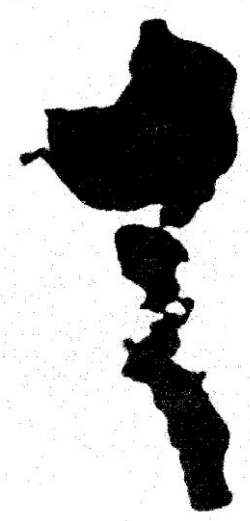

- Adopt and carry out lake protection and rehabilitation plans
- Maintain liaisons with state government officials involved in lake protection and rehabilitation
- Control the fiscal matters of the district, subject to the powers and directives of the annual meeting
- Contribute articles/items for website
- Attend applicable statewide meetings and training
- Oversee committees and recruit volunteers
- Attend 9 Board Meetings and 2 general meeting per year.
- Be willing to serve as an Officer (Chairperson, Treasurer, Secretary)

Chairman (Officer)

- Preside at the Annual meeting, at all Special meetings and Board meetings and public hearings in such a way as to ensure that they are conducted legally and on time

46 Voting District residents were present.

Meeting was called to order @ 9:05 a.m. by Gary Ovick

Approve agenda:

Marianne Shira made a motion to accept the agenda, seconded by Ann Layton. Motion carried.

Secretary's report:

Minutes from the annual meeting August 25, 2012 were presented. Dick Larson motioned to accept the minutes from August 25, 2012, seconded by Ann Wasescha. Motion carried.

Treasurer's report: Jerry Tack presented the 7/1/2013 treasurer's report.

Kel Kobernick motioned to approve the report and was seconded by Beth Hartman. Motion carried.

Annual audit for 2012: Jerry Tack presented an Audit report performed by Joel Hazzard.

Bev Medvec motioned to approve the report, seconded by Jeri Diaz. Motion carried.

Grant Status:

Gary Ovick reported and gave an overview of the APM grant, the CBCW grant and the Navigation grant. We received a one year extension for the APM grant for clp treatment to continue. The CBCW grant was awarded by the DNR on 8/1/2013. A new grant application has been filed for 2014-2016 APM and is pending. The Navigational project of Dredging between Church Pine and Round Lakes has been completed as of July, 2013. We received a 50% grant for that project.

COMMITTEE REPORTS:

Aquatic Plant Management: Steve Oswald gave a report.

Curly Leaf Pondweed: Turions leveling off around 15%. CLP plants down to very few.

08/24/13 Minutes



Purple Loosestrife: Wet winter delayed this year's crop. Treated once on August 15 and will treat again as requested.
 Chinese Mystery Snails: Still present. No plan for eradication.
 Japanese Knotweed: A few spots have been identified locally.
 Eurasian Milfoil: Non present as relayed from Diver from August Dive Survey.
 Zebra Mussels: Non present as relayed from Diver from August Dive Survey. Diver Inspection: Diver reported good news.
 Volunteers: Spotters needed to look out for all invasive species. Contact Steve Oswald or Gary Ovick with any information or questions. Steve Oswald called out for fishermen with cameras to be on the lookout for Eurasian Milfoil.

Clean Boats Clean Waters: Gary Ovick reported.
 Gary noted that 1 in 5 boats used a different water body within a week and could be carrying an invasive species.
 Camera: Camera is operating at 100% monitoring.
 SWIMS: We are now wi fi capable at the beach and can input data in real time.
 Access to videos: Can now access the videos while on duty as CBCW employee.

Dams: Steve Oswald reported.
 It is not necessary to hire an engineering firm to survey our dams per the DNR. A common sense approach has been undertaken.

Fish Stocking: Bob Meyer reported.
 We have been using the wrong fish dna for the last ten years and that prevented us from stocking last year. The DNR is allowing a maximum number of fish to be released. A supplier has been contracted and will await the optimum weather conditions to restock. Cost of this year's stocking: \$7,000. The lakes need to be stocked due to too much pressure from over-fishing. We support sport fishing.

Navigation Committee: Jerry Tack reported.
 The channel between Round and Church Pine lakes was dredged at a cost of \$7,440. A grant paid for half for a total cost to the District of \$3,720. The District added a No Wake buoy at the landing in Big Lake.

Social Committee: David Zanick reported.
 Two events were held this year; the Social Dinner (53 attended) and the July 4th Parade (36 boats entered). Both were successes and no complaints were heard. May 17th is the next Social Dinner. Next year the Parade is on Big Lake only.

Water Patrol Committee: Tom Bach reported.
 Our new Sheriff contact is Deputy Keith Brantner. As of this report there were 14 boater contacts with 5 inspections, 3 warnings, 3 citations and 3 tows. 72 hours in 11 shifts were logged and one weekend was rained out.

Lake Management Committee: David Zanick reported.

08/24/13 Minutes



In conjunction with the Polk Co. Land & Water Resource Department, we received a grant and the District now has a 120 page Water Quality Plan. This plan is available for review at the Website. The District is awaiting DNR approval. The plan's primary goal is to reduce phosphorus and algae. A survey is being mailed to the District upon DNR approval of the plan. North Creek has been studied and is a major phosphorus contributor.

Website Committee: Jerry Diaz reported.

The format has changed over the last few years and the new design was reviewed. District meetings are posted on the website as is the Grants, Plans, etc.

Proposed Budget 2014: Jerry Tack gave overview.

Ann Wasescha motioned to approve and Ann Layton seconded. Discussion regarding a funds cap was brought up. There exists a cap of 2.5% of the Levy. Motion carried.

Board proposal regarding Fiscal Management: Gary Ovick presented

"Whereas the Voters have approved an annual total budget; The Board of Commissioners recommends that the Voters at the August 24th 2013 Annual Meeting approve the Board's authority to reallocate up to \$5,000 between budget categories without calling a Special Meeting." Pat Durkin made the motion and Tom Diaz seconded. Discussion centered around the fact the Board had been operating this way all along. Motion carried.

Board proposal regarding the obsolete 1995 By Laws. Gary Ovick presented.

"Whereas the State of Wisconsin has comprehensive statutes governing the operation of Lake Districts and its public officials; The Board of Commissioners recommends that the Voters at the August 24th 2013 Annual Meeting rescind the By-Laws of the Church Pine, Round and Big Lake P & R District in favor of compliance with the Laws of the State of Wisconsin." A motion was made by Pat Durkin and a second by Tom Bach. Discussion included that most of by-laws were trumped by State laws, and the example that requiring a Board Member be from each lake is not legal. Motion carried.

Election of Commissioners: Gary Ovick presented.

The Board presented Mike Reiter and Ann Layton to replace outgoing David Zanick and Heidi Hazzard. Both were approved in a unanimous vote.

Gary Ovick presented the proposed District Calendar.

Motion to adjourn:

Tom Diaz motioned to adjourn the meeting at 11:36 a.m. and Rochelle Starbuck seconded. Meeting adjourned.

My audit concluded that the financial documents are in order and that great care has been taken to ensure all payments, etc. have been properly recorded and with sufficient backup records and information with the noted exceptions;

No invoice for check 3235 made out to West Immanuel in the amount of \$250 for use of their facility for the Spring Church Pine, Round and Big Lake Protection and Rehabilitation District meeting.

No invoice for check 3267 made out to West Immanuel in the amount of \$250 for use of their facility for the Fall Church Pine, Round and Big Lake Protection and Rehabilitation District meeting.


No invoice for check 3268 made out to the Women of West Immanuel in the amount of \$50 as a donation for helping with the Fall Church Pine, Round and Big Lake Protection and Rehabilitation District meeting .

No support information is available for check 3270 made out to Lake Maintenance Fund in the amount of ~~\$2,965.65~~: \$2,500

I also noted that the invoice description does not match the Operating Account summary description for check 3251 in the amount of ~~\$2,965.50~~ ^{\$3,128.60} made out to J&S Contracting where the invoice description states "Restoration of shoreline and driveway at Keith Hartman residence. Also includes seeding of wildflower mix in disturbed area" where the Operating Account report description states "channel dredging".

In addition I noted the following over budget line items; Purple Loosestrife Control, Surveillance Cameras Service, Water Patrol Labor & Expenses, Website, Fish Stocking and Water Quality. There were also several budget line items that were under budget as well.

RE: Response to Financial Audit – 2013

The audit of the District's 2013 financial records was performed by Joel Hazzard as of June 19, 2010. Please refer to Mr. Hazzard's comments of the same date. Mr. Hazzard noted 5 exceptions. They are addressed as follows:

No invoice for checks 3235, 3267 and 3268. These checks were all written to West Immanuel Church for the use of their facility and refreshments for meetings. The church does not bill the District. The fee is a verbal agreement between the Church and the District.

Reconciling dredging expense – In November of 2012, a \$4320 check was issued from the operating account to pay the first portion of dredging the channel. Likewise we received \$2475 in DNR grant, which was deposited into the operating account, for a difference of \$1875. Dredging expense and grant funds were to be accounted for within the Lake Maintenance Fund. To reconcile this, on 5/13/13 \$1845 was transferred from the LMF to the operating account to fully reimburse the operating account for the dredging expense. Likewise on July 24, 2013, check 3251 in the amount of \$3218.60 was written from the operating account to pay the final dredging installment. On 8/1/2013, \$3218.60 was transferred from the LMF to the operating account to reimburse the operating account. Finally, on 10/21/13 grant proceeds from the DNR in the amount of \$1249.30 were deposited into the LMF. Please note that the restoration of the shoreline was part of the dredging project.

To avoid comingling of account funds in the future, checks and deposit slips for the Lake Maintenance Fund and the Rapid Response Fund have been obtained.

The \$2500 check (#3270) to the LMF was an approved budget item. No invoice was required.

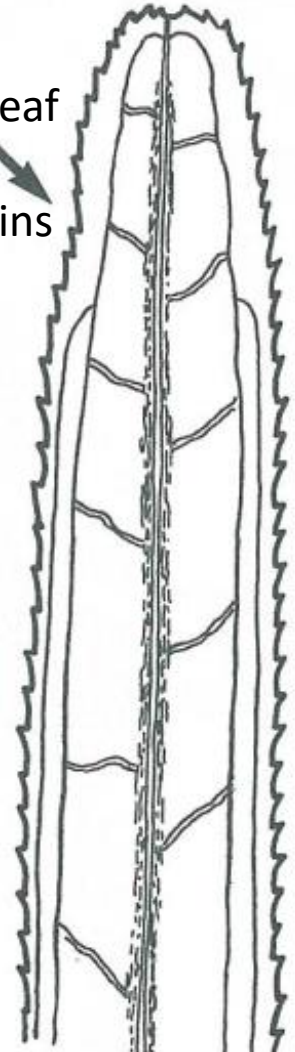

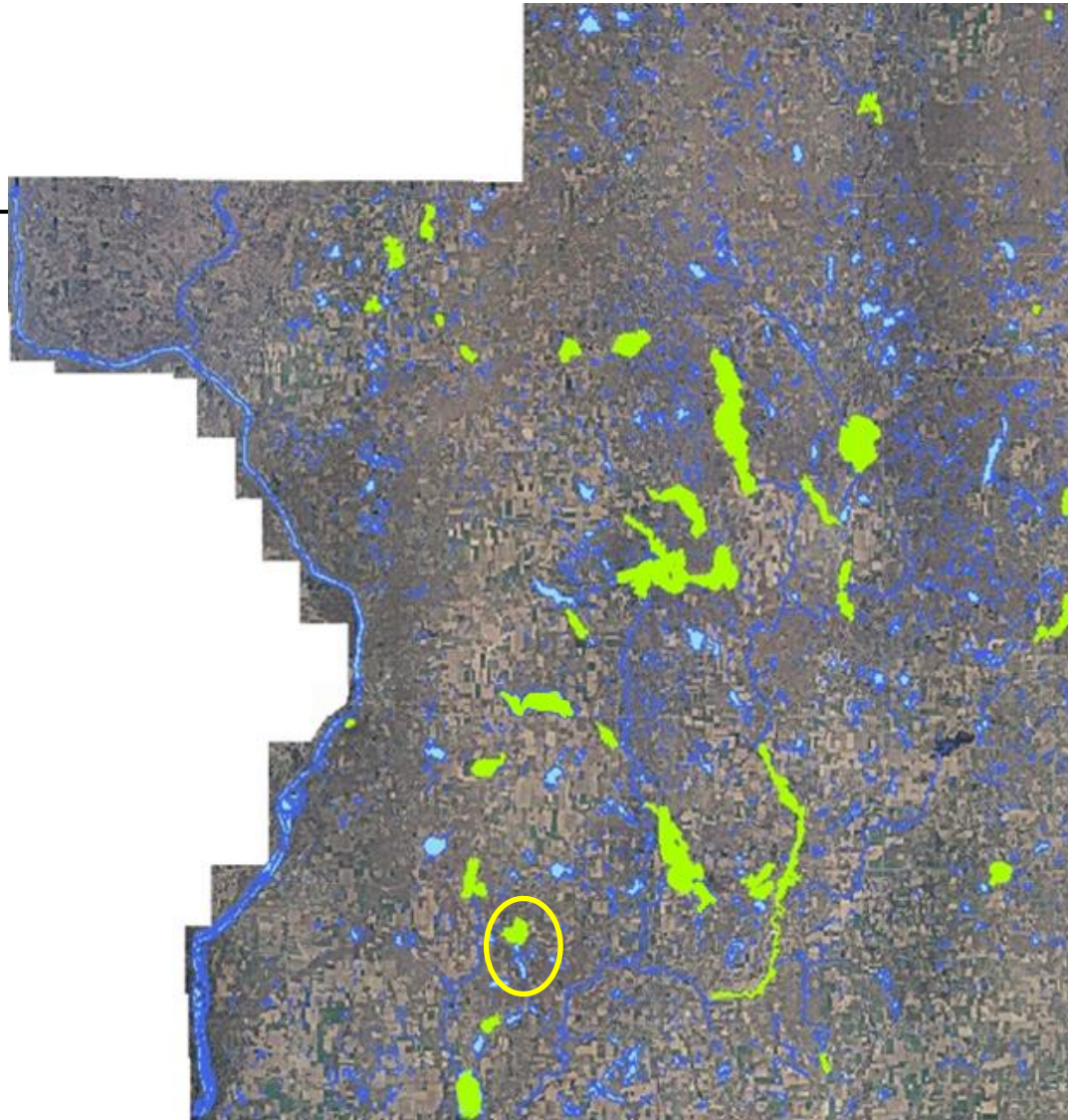

CLP areal coverage-all treatment beds

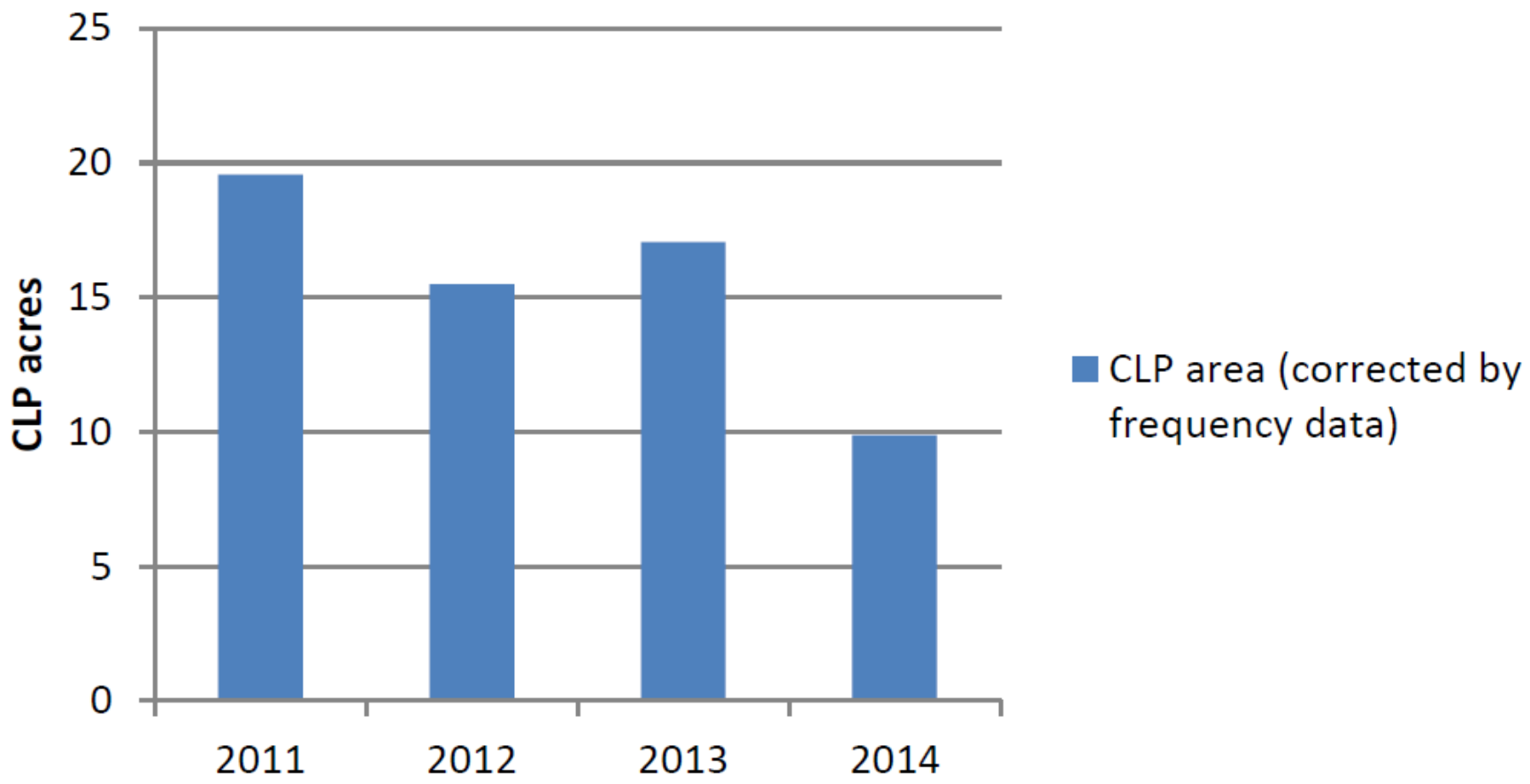


Figure 10: CLP areal coverage of all beds for each year 2011-2014.

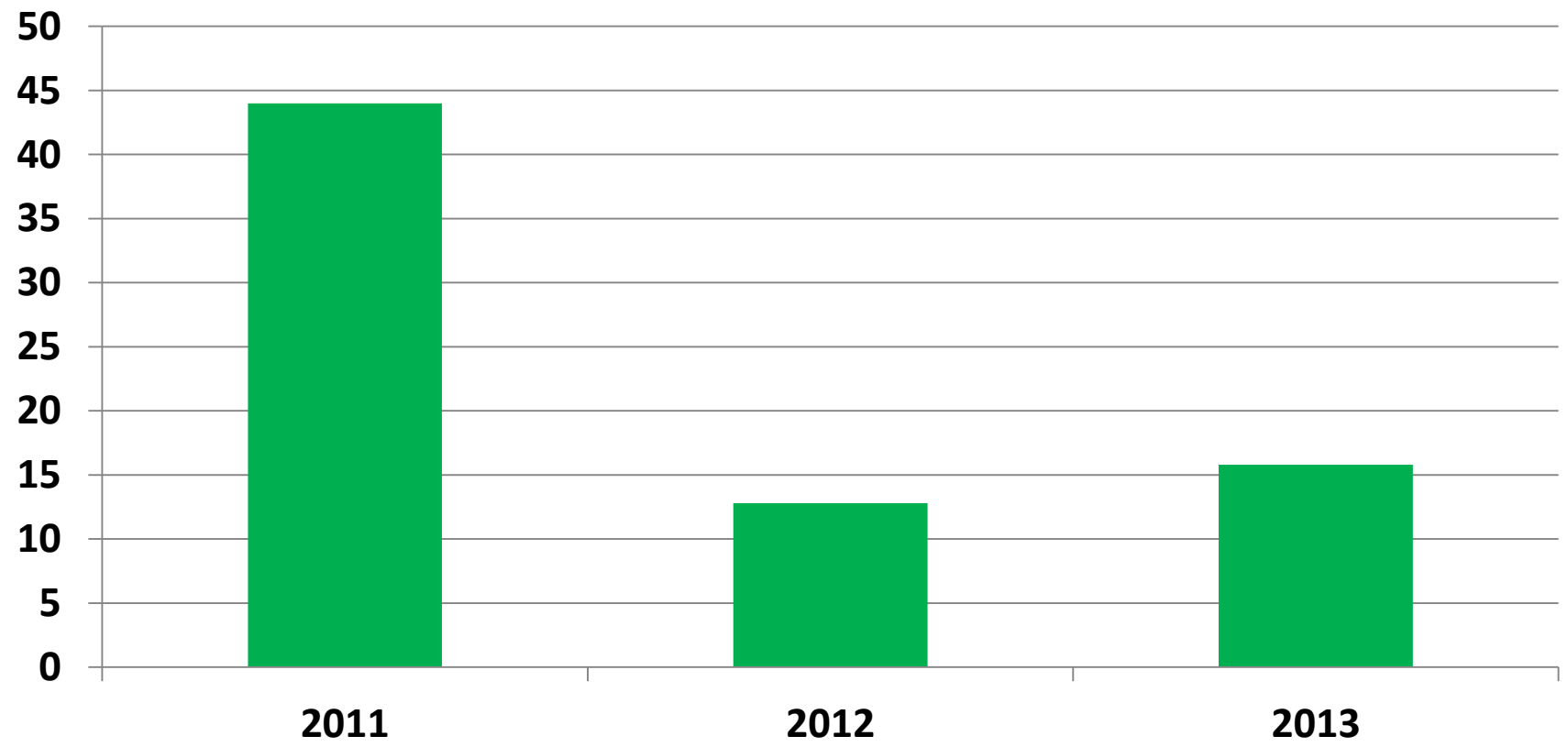
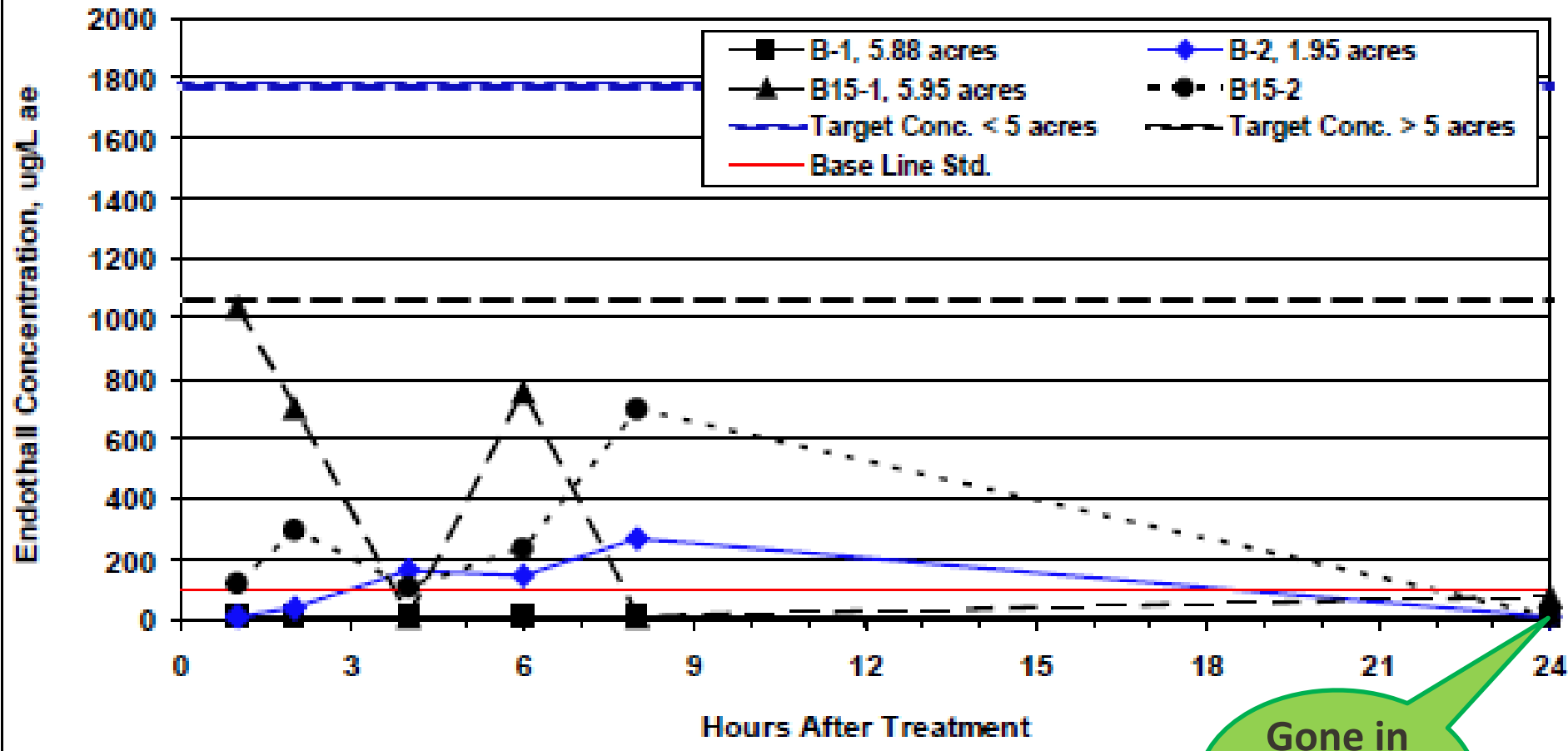

Big Lake, Polk County Endothall Concentrations, 2013

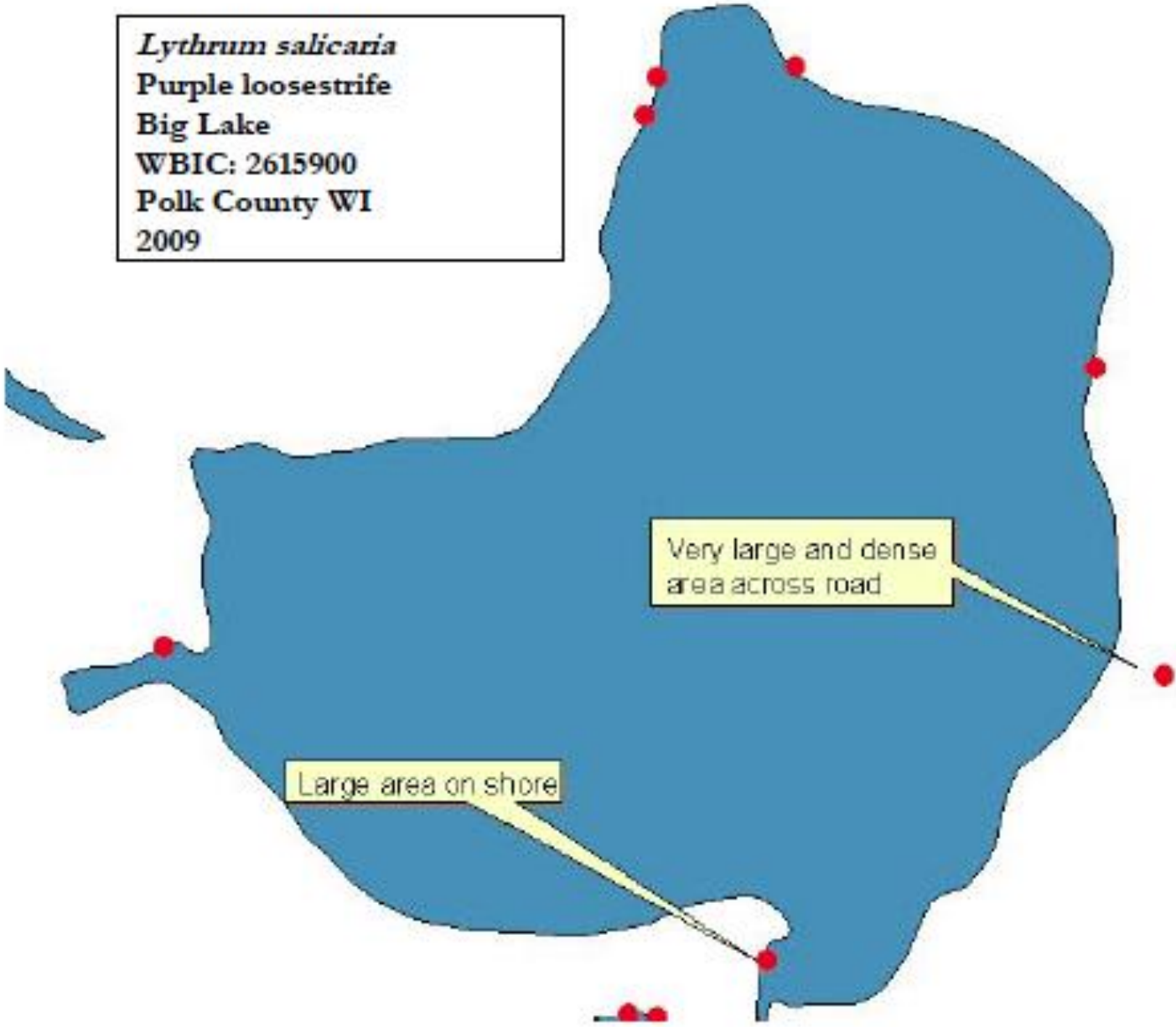

'Operation Beetle' project to battle invasive plant

To help eradicate an invasive plant species called Purple Loosestrife, the Lake District of Churchpine, Round and Big Lakes recently partnered with the Wisconsin DNR and Meyer Middle School of Riverfalls Wisconsin on a project called 'Operation Beetle.'

River Falls Meyer Elementary school science teacher, Karen Ye was contacted by Bruce Balck a resident of Churchpine lake and member of the lake district's aquatic plant committee about the possibility of this project. Balck said that "Ms. Ye immediately volunteered because this project paralleled her lesson plan objectives that she teaches as a part of her science curriculum". In mid-April the Purple Loosestrife root balls and beetles were obtained and were raised in the school's greenhouse by Karen's students.

The beetles called *Galerucella* were obtained from Brock Woods of the Wisconsin Department of Natural Resources (DNR). Karen said that "Brock has been an incredible resource on this project from providing the

beetles and netting as well as providing a wealth of educational materials."

Purple loosestrife is an aggressive perennial plant of European

and Asian origin found in 47 states of the the United States and is commonly found along marshy areas and shorelines.

Purple loosestrife is a significant

problem because it displaces native wetland plants and can become the dominant plant, thereby reducing plant diversity and changing the ecosystem of a

wetland. A single purple loosestrife plant with multiple stems can produce up to two million seeds that are easily dispersed along rivers and waterways.

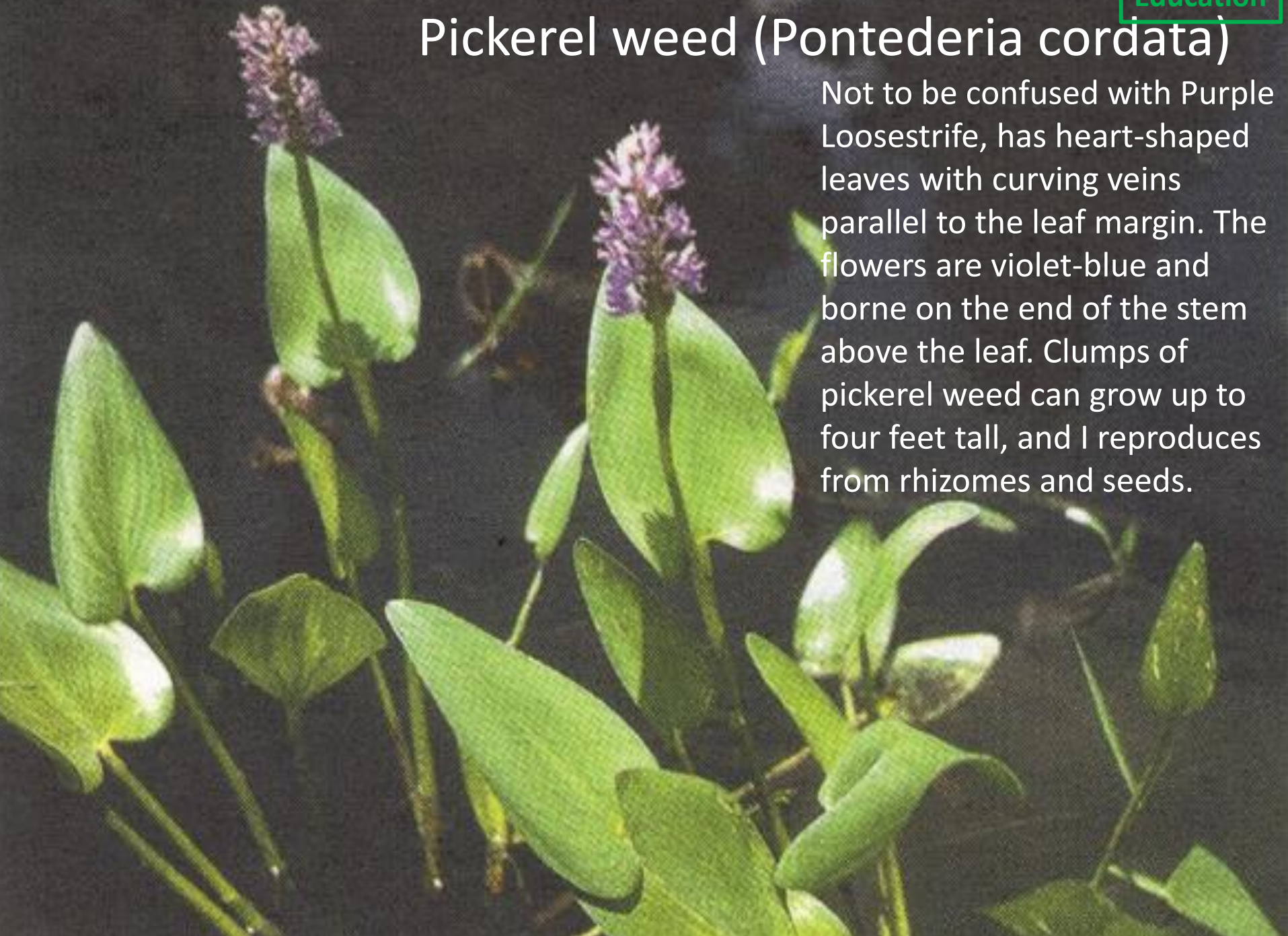
The leaf-feeding beetles reduce the growth and reproduction of purple loosestrife. The adult beetles feed on the leaves of purple loosestrife and lay their eggs. Once the eggs have hatched, the larvae feed on the leaves and stems as they move down into the soil. The larvae cause the most damage to the plant and reduce the number of seeds produced.

The beetles feed primarily upon purple loosestrife and either move on or die without the presence of Purple Loosestrife. The beetles were released the first week of June on the north marsh area of Big Lake. "It may take several years for the Loosestrife to be completely eradicated but is well worth the effort" Balck said.

Pickerel weed (*Pontederia cordata*)

Not to be confused with Purple Loosestrife, has heart-shaped leaves with curving veins parallel to the leaf margin. The flowers are violet-blue and borne on the end of the stem above the leaf. Clumps of pickerel weed can grow up to four feet tall, and it reproduces from rhizomes and seeds.

Landowner's Options *for* Lakeside Plant Removal

1. Remove a 30 foot wide access out to the lake from the shoreline (25 foot in a Critical Habitat Area).

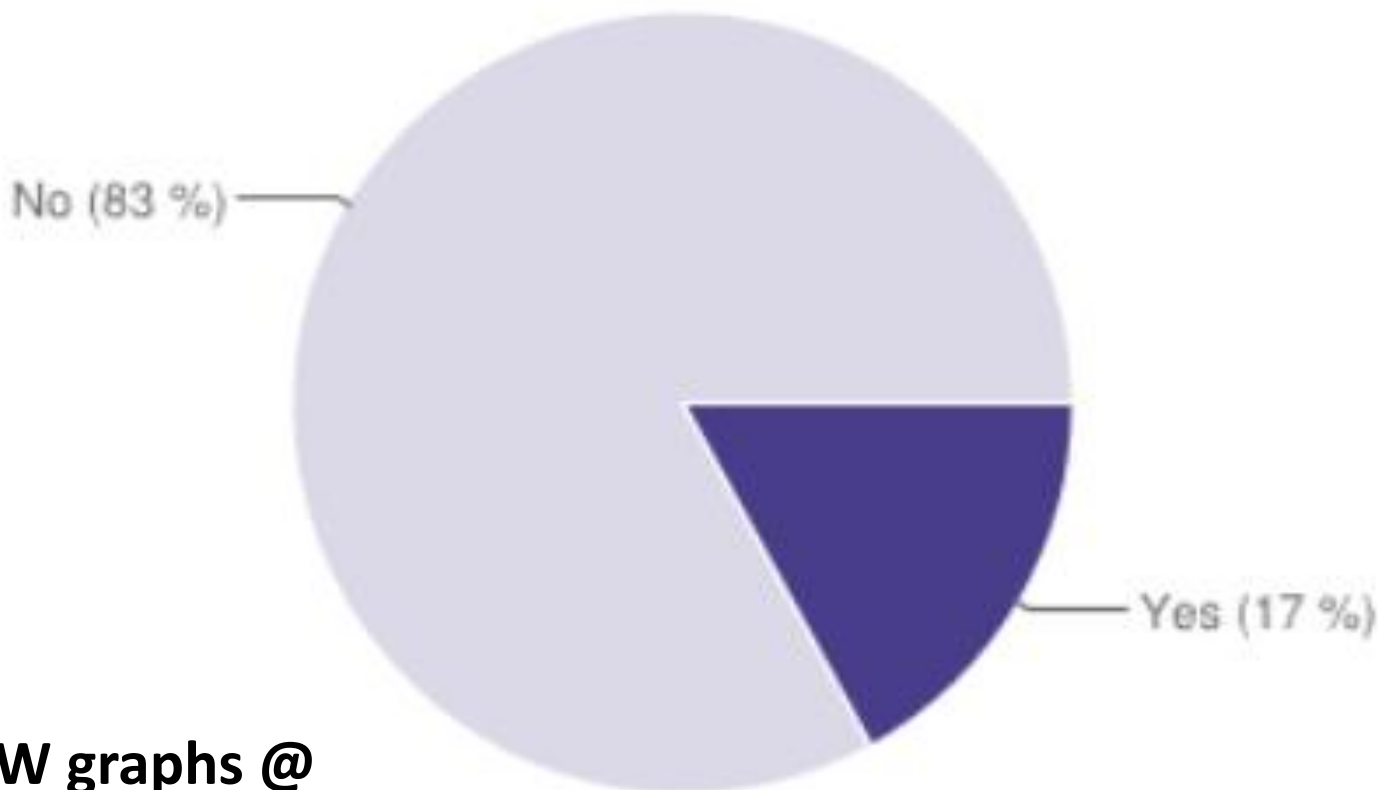

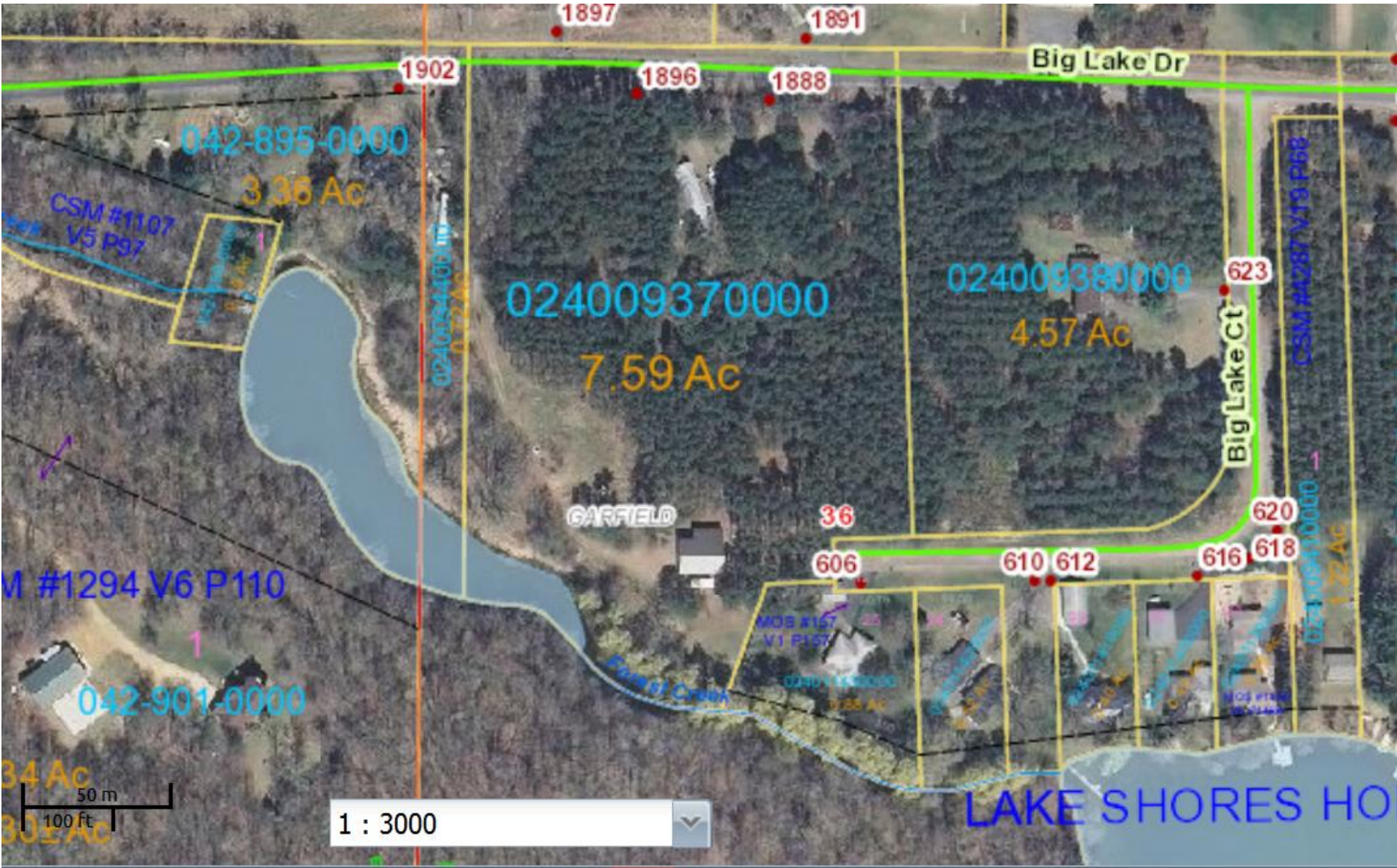

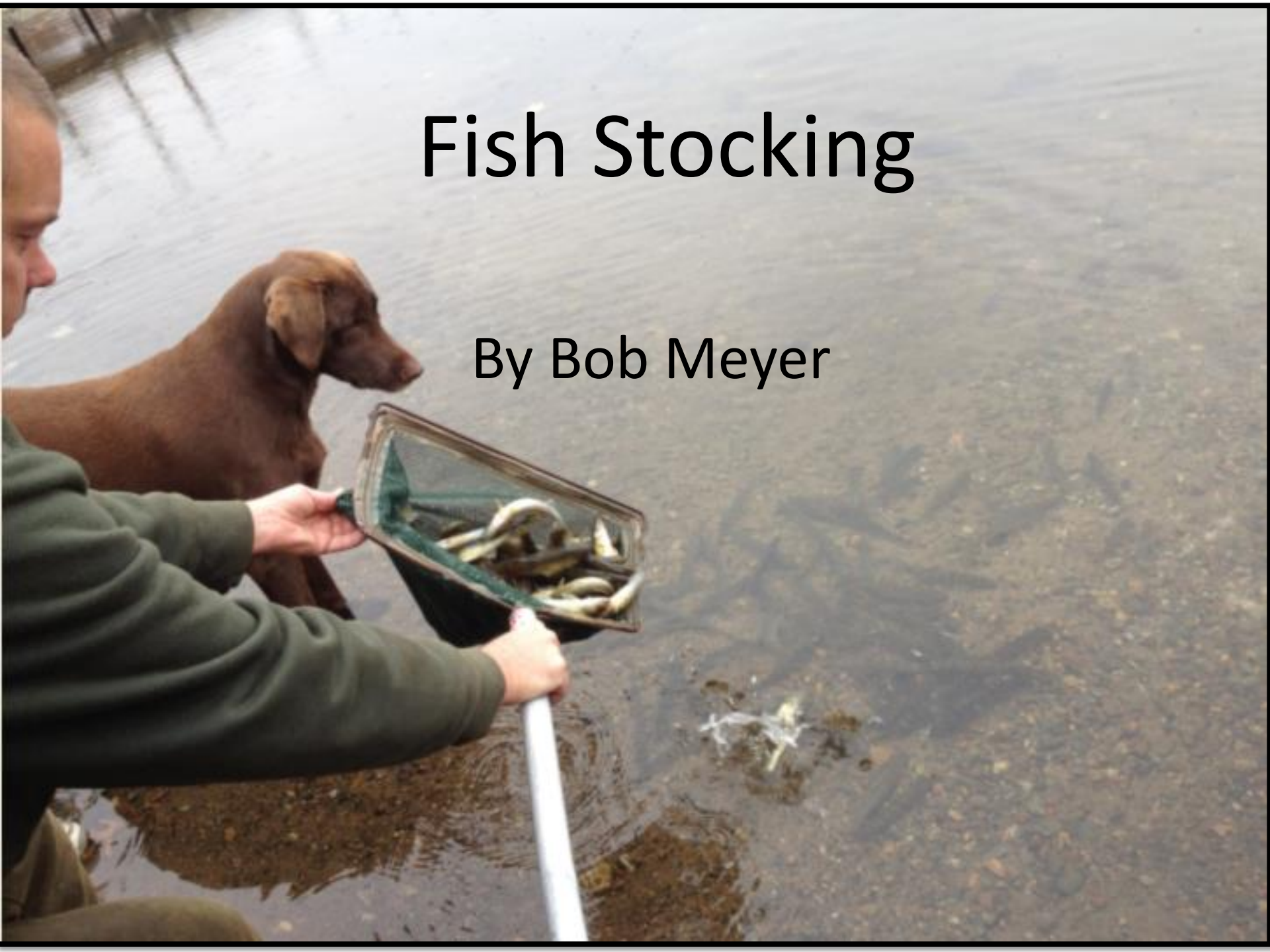

Slow No Wake Buoys



The No Wake zone on the Church Pine side of the channel was extended further south into the main body of the lake. This will help reduce stirring of the sediment which in turn will reduce the need for future dredging of the channel. There is now two Slow No Wake buoys on Church Pine to mark the extended No Wake zone.



Boating Regulation *Reminders*



- **Slow, No Wake** speed means, a speed at which a vessel moves as slowly as possible while still maintaining steerage control.
- A No Wake zone extends out to 100 feet from any shoreline for Boats.
- PWC may not be operated faster than No Wake speed within 200 feet of the shoreline.

New Area of Enforcement: Buoy SNW Zone

From Deputy Jeff Hahn

One law I would like to address with your members is:

30.66(3)(a) (which is defined as) No person may operate a motorboat within 100 feet of any dock, raft, pier, or “buoyed restricted area” on any lake at a speed in excess of slow-no-wake.

- This came to the Sheriff as a complaint from Lake Wapogasset where boats routinely approach the narrows and reduce speed within feet of entering the SNW buoyed area and come to full throttle within feet of leaving the same area.
- Similar to the SNW areas on your chain...these areas restricted to SNW do fit into that “buoyed restricted area” definition.
- We at the Sheriff’s Department to my knowledge have never enforced that 100’ violation outside the SNW area. We would like to address it and educate this season.
- Next year we will enforce that law uniformly and undoubtedly catch many people unaware of that restriction and unfortunately surprise them with the corresponding \$187.50 fine.



*Polk County Sheriff's Department
in conjunction with local Lake Associations actively
patrols this lake. Many of the most common complaints
brought to the Polk County Sheriff's Department Water
Patrol are briefly addressed below.*

REGISTRATION: all boats (other than sailboats under 12' and manually propelled boats which do not have a motor) and PWC's must possess both a "Certificate of Number" (registration numbers) and Expiration Decals displayed on the front half of the bow in contrasting colors to the rest of the hull. This means both the annual sticker and the full registration number must be displayed. Boats kept on Wisconsin lakes for 60 consecutive days MUST be registered in Wisconsin. Fine for violations range from \$162.70 to \$200.50 and can be issued to operator OR owner.

UNDERAGE OPERATION: ANY operator born after January 1st, 1989 must possess (and be able to show) a Wisconsin approved Boater's Safety Certificate. Persons under the age of 12 may not operate a PWC. Persons between 10 years of age and 12 years of age may operate a boat only WITH direct parental supervision. Permitting underage operation or operating without Safety Certificate carries a fine of \$162.70.

PWC SPECIFIC RULES: PWC's may not be operated at greater than Slow/No Wake (SNW) speed within 200' of shore or within 100' of another vessel, dock, raft, or a person water skiing. This means the slowest speed possible to maintain control. PWC's may not be operated between sunset and sunrise. PWC's may tow a skier/tube rider if the PWC is designed to carry THREE persons and a "competent spotter" is riding and facing backward with the operator. More than one skier or tuber rider is allowed. All persons riding on or being pulled by a PWC must use approved Personal Floatation Device (PFD). PWC's must possess a fire extinguisher. Fines for these violations range from \$175.30 to \$200.50.

BOAT SPECIFIC RULES: Boats may not be operated at greater than SNW within 100' of shore, a water skier, dock, raft or buoyed restricted area (including SNW area). No persons are allowed to ride on boat decks or gunwales (side of the boat, seat backs, sun decks or seats on raised platforms). All boats operated between sunset and sunrise must use required lighting. Boats may not exceed restrictions of Capacity Plates, must possess sufficient PFD's for all passengers and must possess a fire extinguisher in a "readily accessible location" if the boat has any closed construction (compartment of any kind). The boat's battery must have terminals covered and be held in place to prevent the battery from moving. Boats must have a competent spotter in the boat when towing skiers (mirrors do not fit Wisconsin's requirement). Towing skiers between sunset and sunrise is prohibited. Fines range from \$162.50 to \$200.50.

RECKLESS OPERATION/INTOXICATED BOATING: Creating a hazardous or dangerous wake, operating in a "reckless manner" or using "unreasonable or imprudent speed" are all illegal. Operating under the influence of an intoxicant or with a detectable amount of a restricted controlled substance can result in fines, an arrest or both. Fines for these violations range from \$162.50 to \$452.50 and can also result in an arrest and criminal charges.

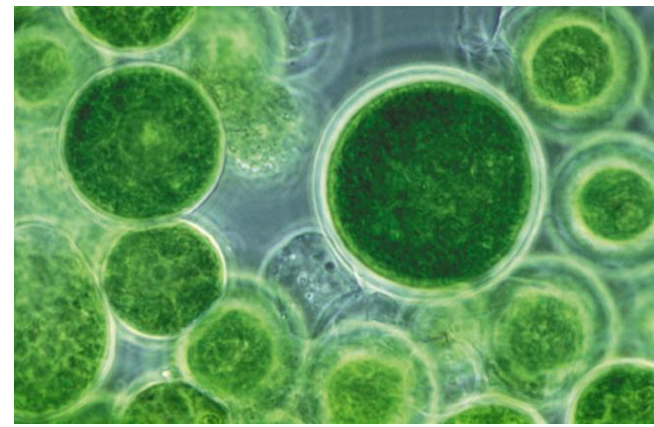

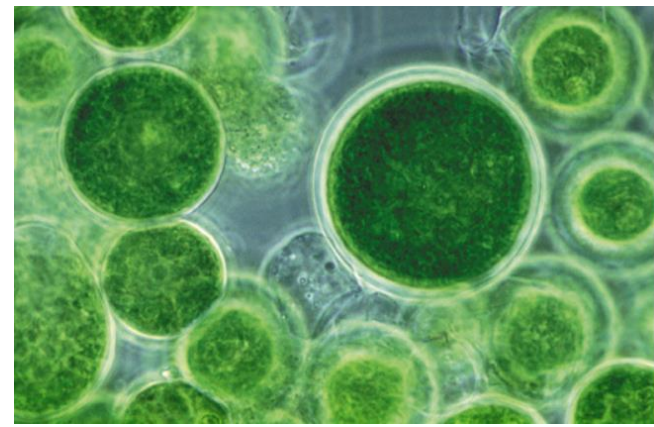

Measure Ground Water Phosphorous in North Creek Wells

- We planned to study ground water phosphorous from North Creek by sampling wells near the creek.
- Well samples should be an indicator of ground water phosphorous.
- If there is a significant amount of phosphorous in the ground water, we will need to focus attention on other sources.
- Well samples have been obtained and results are pending



Water Quality Committee

Future Plans

- Apply for another lake planning grant due December 10, 2014.
- This will be a smaller grant to study in lake phosphorous to determine how much is coming from *sediment*

Healthy Lake Implementation Plan (HLIP)

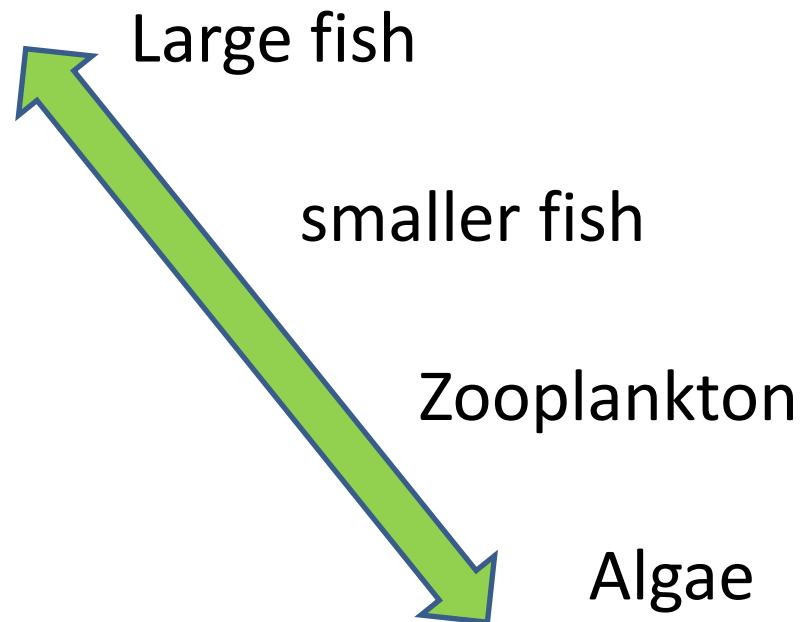

Frequency of CLP at Sample Points

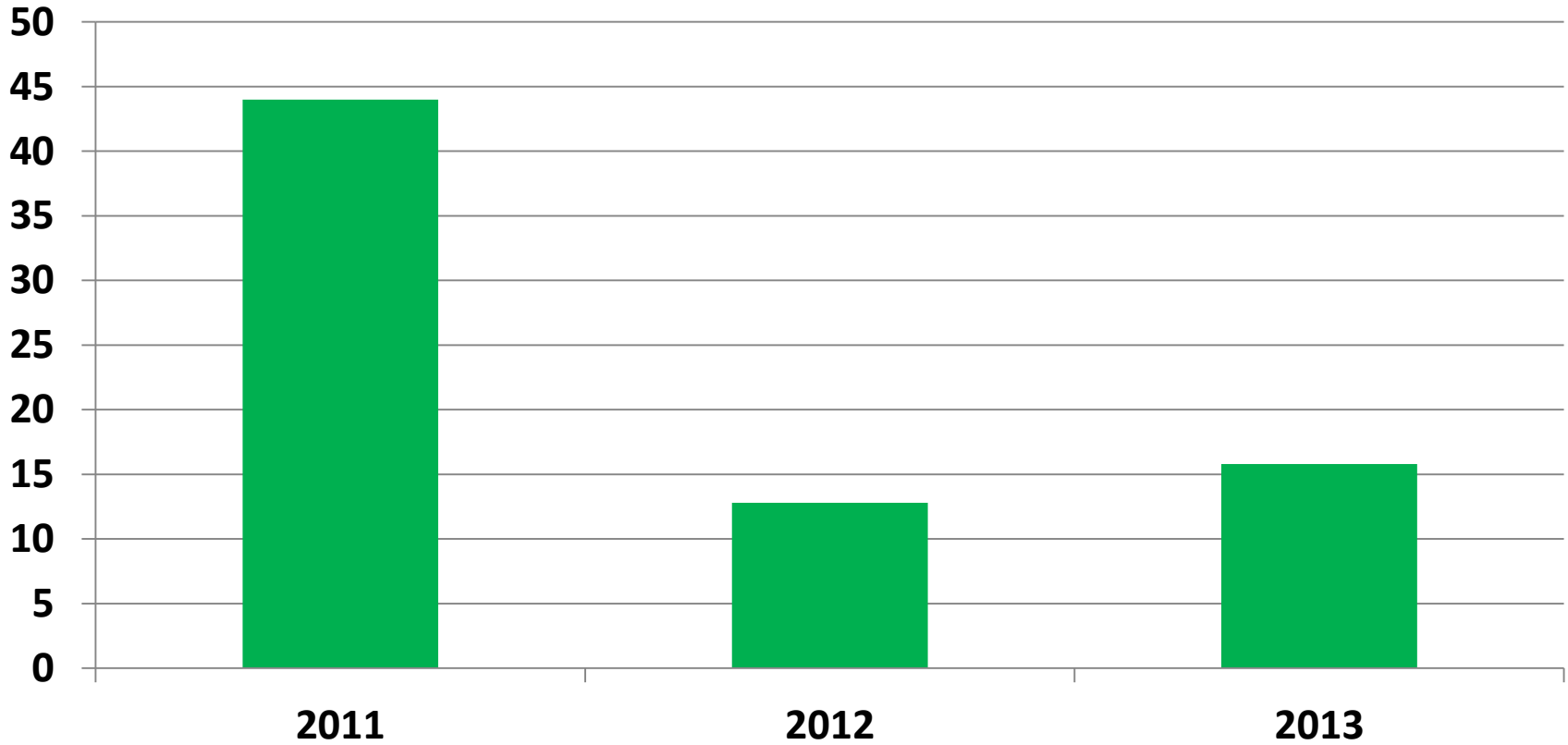

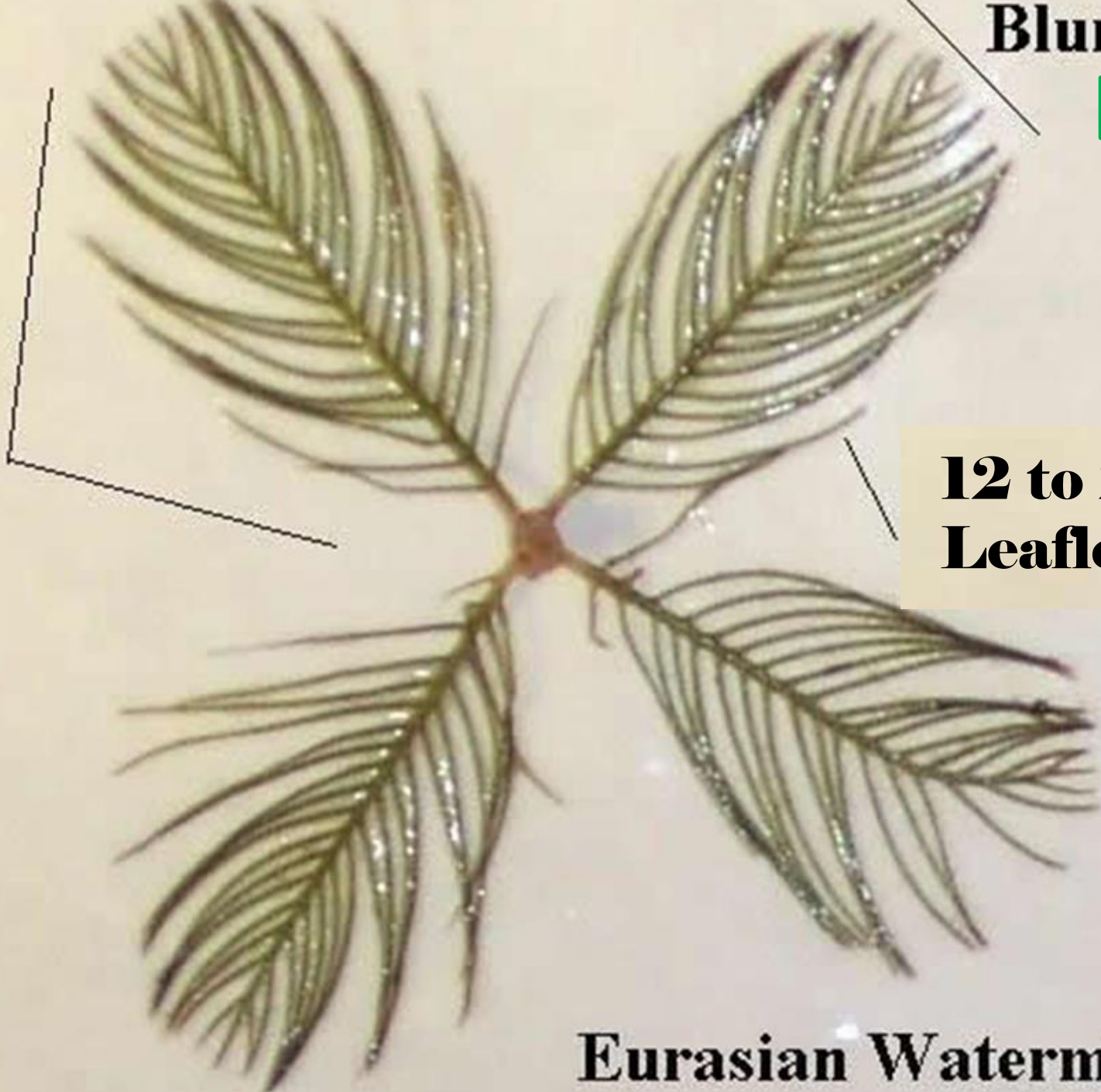

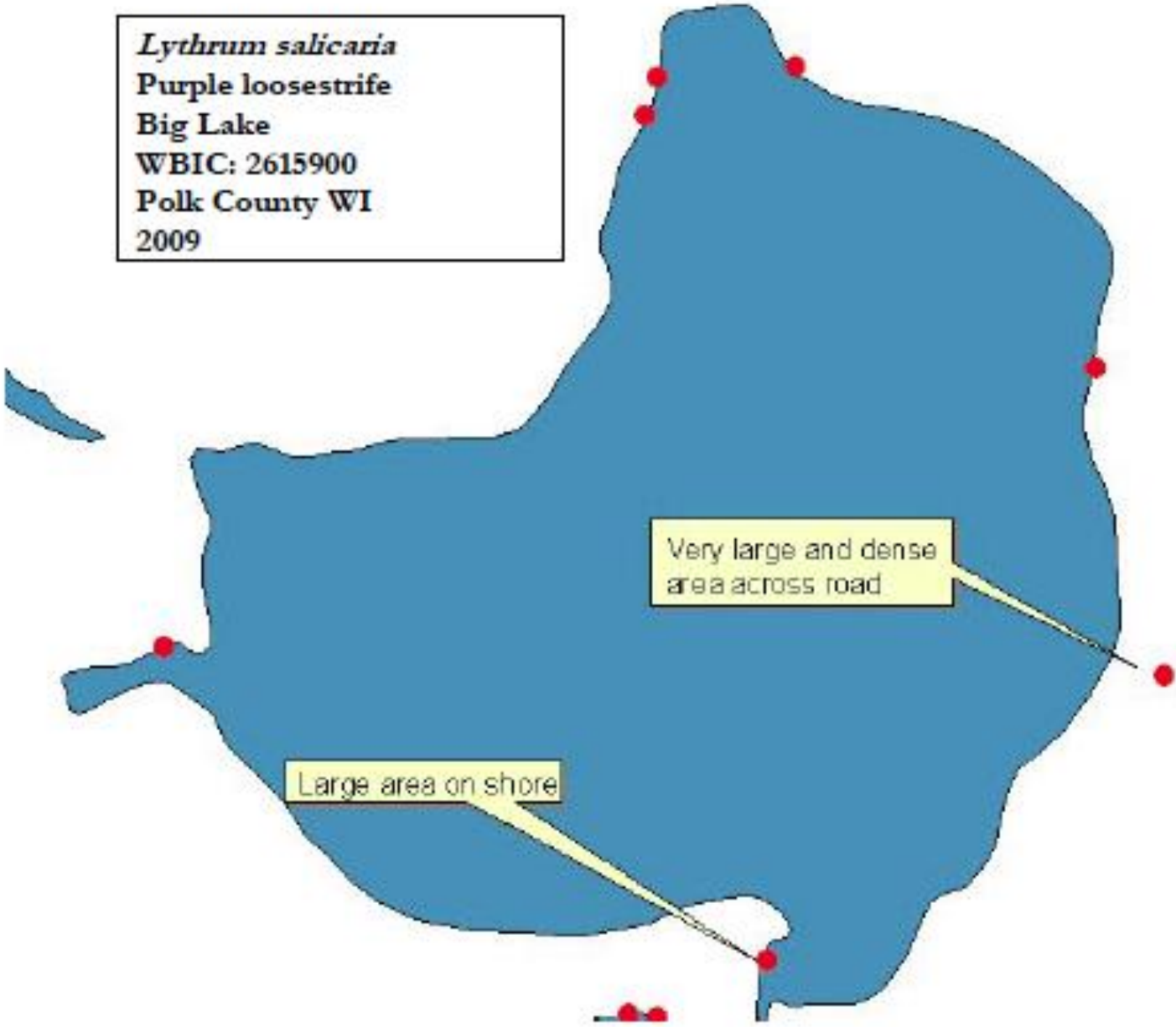

'Operation Beetle' project to battle invasive plant

To help eradicate an invasive plant species called Purple Loosestrife, the Lake District of Churchpine, Round and Big Lakes recently partnered with the Wisconsin DNR and Meyer Middle School of Riverfalls Wisconsin on a project called 'Operation Beetle.'

River Falls Meyer Elementary school science teacher, Karen Ye was contacted by Bruce Balck a resident of Churchpine lake and member of the lake district's aquatic plant committee about the possibility of this project. Balck said that "Ms. Ye immediately volunteered because this project paralleled her lesson plan objectives that she teaches as a part of her science curriculum". In mid-April the Purple Loosestrife root balls and beetles were obtained and were raised in the school's greenhouse by Karen's students.

The beetles called *Galerucella* were obtained from Brock Woods of the Wisconsin Department of Natural Resources (DNR). Karen said that "Brock has been an incredible resource on this project from providing the

beetles and netting as well as providing a wealth of educational materials."

Purple loosestrife is an aggressive perennial plant of European

and Asian origin found in 47 states of the the United States and is commonly found along marshy areas and shorelines. Purple loosestrife is a significant

problem because it displaces native wetland plants and can become the dominant plant, thereby reducing plant diversity and changing the ecosystem of a

wetland. A single purple loosestrife plant with multiple stems can produce up to two million seeds that are easily dispersed along rivers and waterways.

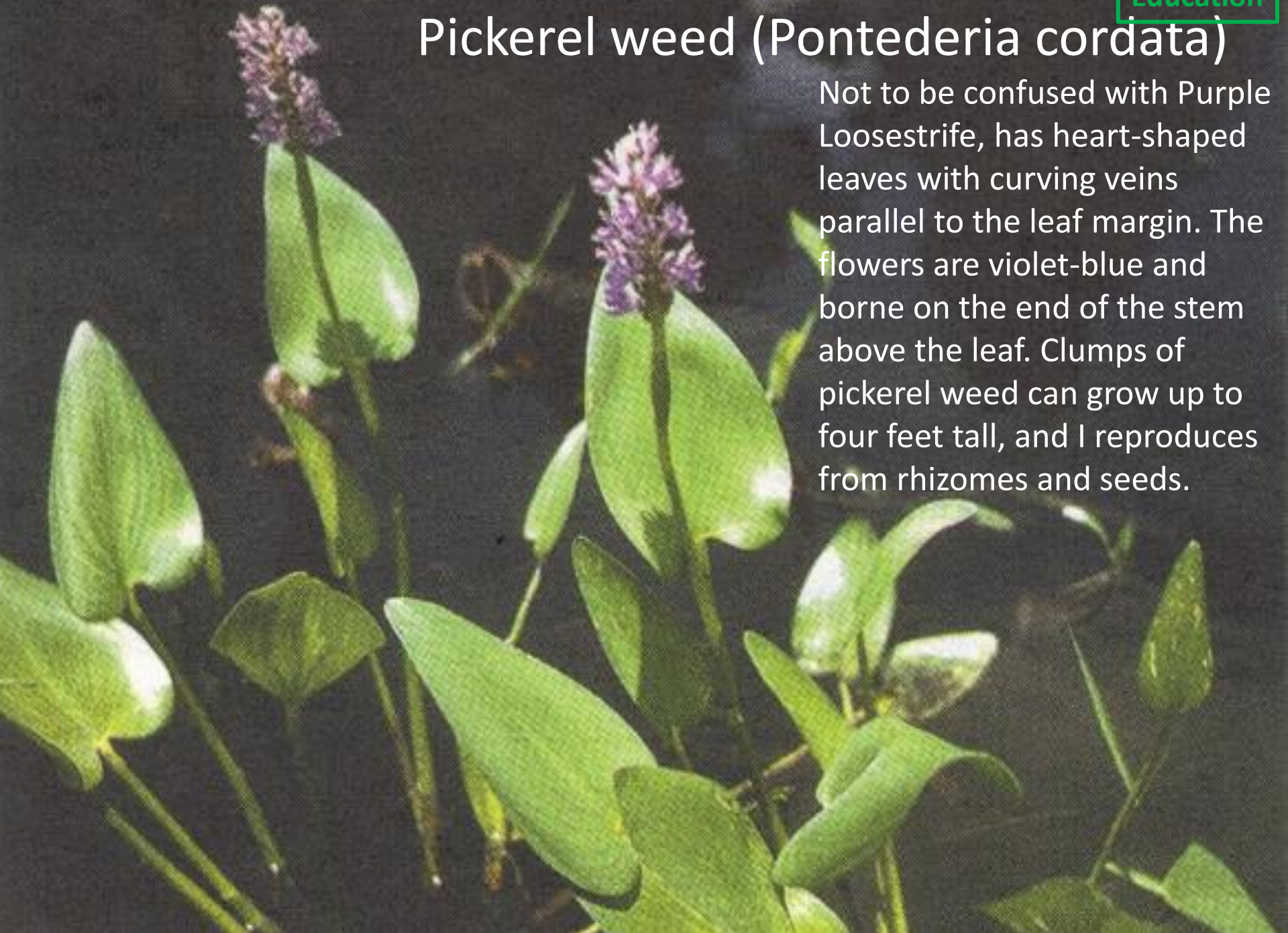
The leaf-feeding beetles reduce the growth and reproduction of purple loosestrife. The adult beetles feed on the leaves of purple loosestrife and lay their eggs. Once the eggs have hatched, the larvae feed on the leaves and stems as they move down into the soil. The larvae cause the most damage to the plant and reduce the number of seeds produced.

The beetles feed primarily upon purple loosestrife and either move on or die without the presence of Purple Loosestrife. The beetles were released the first week of June on the north marsh area of Big Lake. "It may take several years for the Loosestrife to be completely eradicated but is well worth the effort" Balck said.

Pickerel weed (*Pontederia cordata*)

Not to be confused with Purple Loosestrife, has heart-shaped leaves with curving veins parallel to the leaf margin. The flowers are violet-blue and borne on the end of the stem above the leaf. Clumps of pickerel weed can grow up to four feet tall, and it reproduces from rhizomes and seeds.

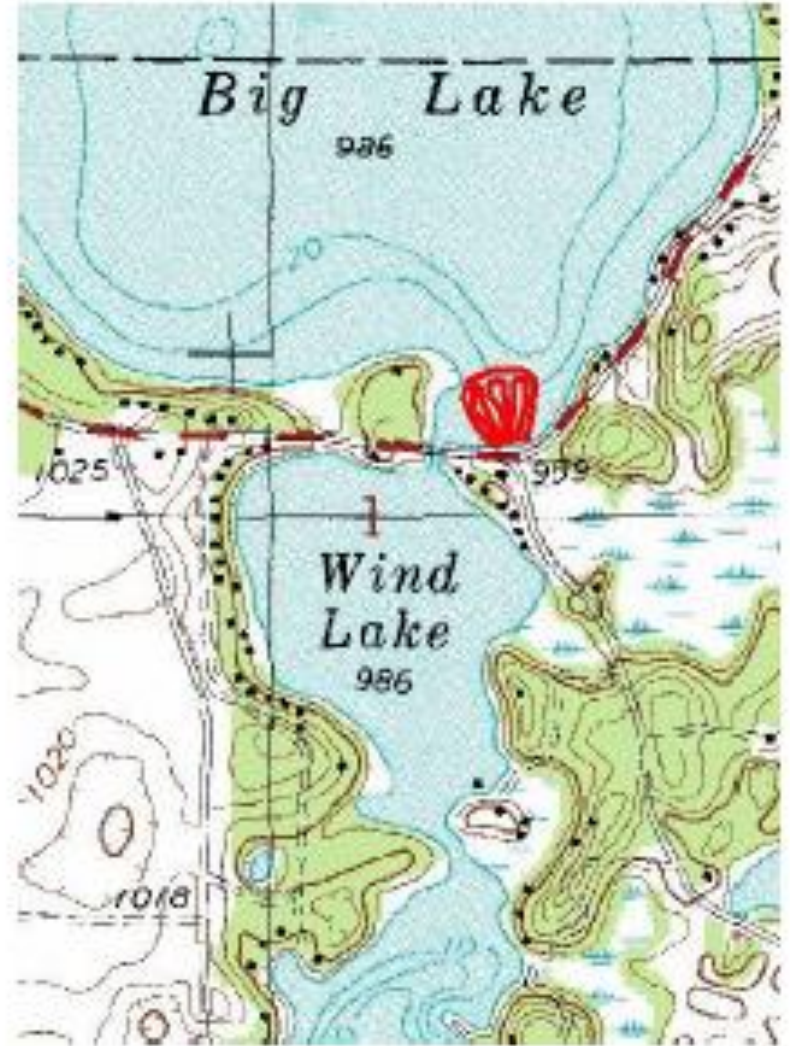

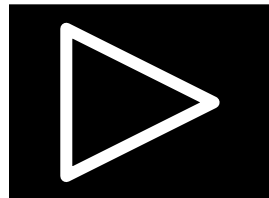
Landowner's Options *for* Lakeside Plant Removal

1. Remove a 30 foot wide access out to the lake from the shoreline (25 foot in a Critical Habitat Area).
 2. Apply for a permit to use herbicide or mechanical means to secure a corridor. There is a procedure to be used when applying for these permits. Cost of the efforts would be at the landowner's expense.
- *** Undesired weeds that are removed should be deposited of in an acceptable manner. They also can be composted and make excellent mulch for on-site gardens.**

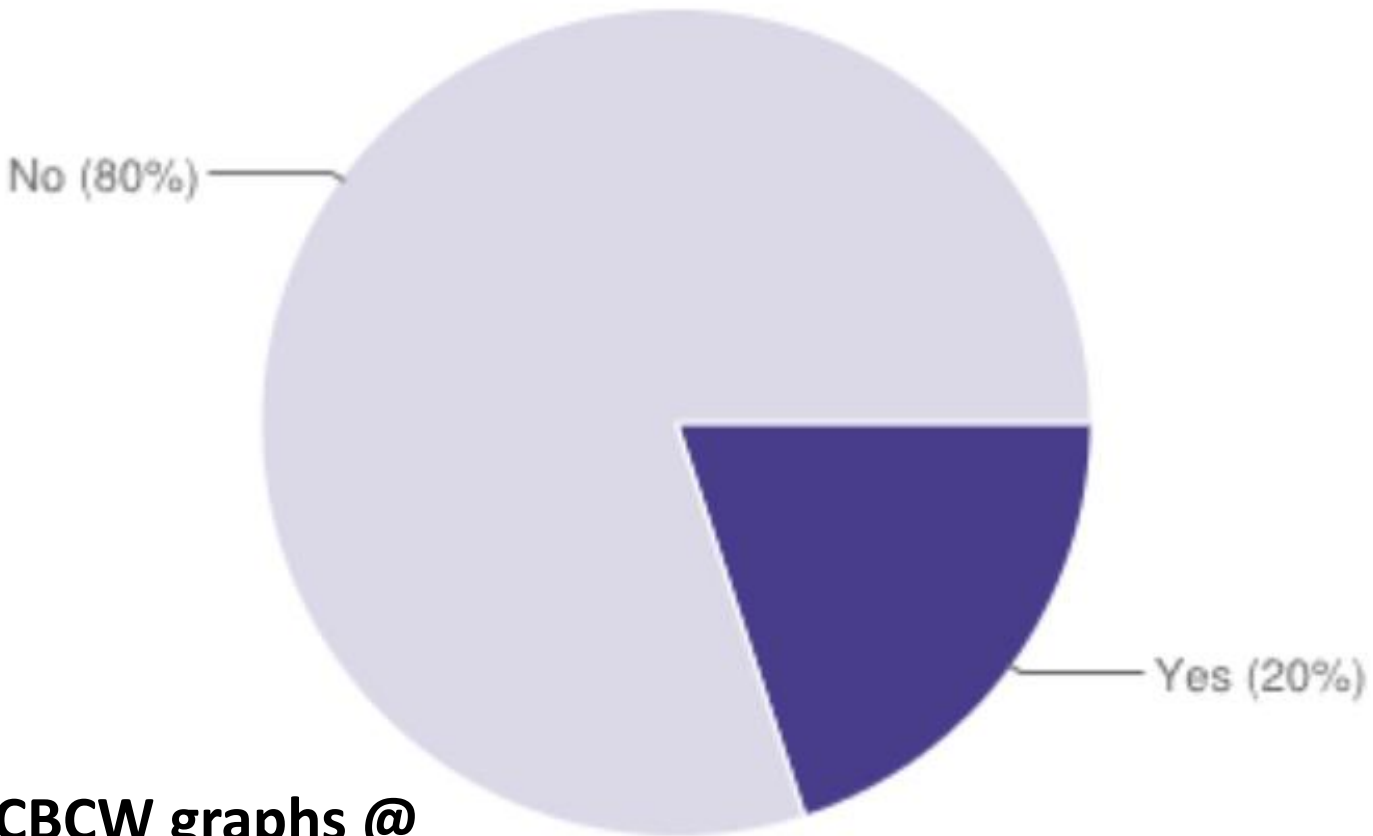

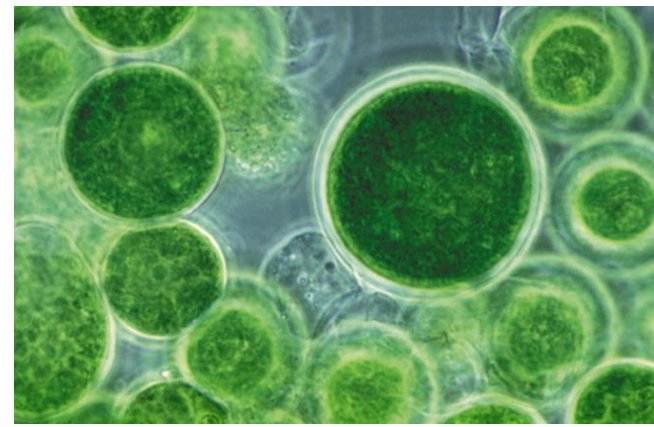

Activities to Consider in 2014

- North Creek: Further clarify the amount of ground water P by doing well samples of adjacent properties.
- WAV analysis of North Creek
- Search for a resident willing to allow a shoreline demonstration project to include, no grass cutting and installation of a 10'X30' planting using an existing design. The district will pay for the materials and the homeowner is responsible for the labor.



Activities to Consider in 2014

- Encourage residents to develop their own small scale designs for shoreline restoration. The District will be applying for a grant to fund a portion of these projects next year. We will need a confirmed list of volunteers to put with the grant application before Feb 2015.
- Preliminary fish stick analysis with WDNR assistance to identify appropriate locations and homeowner interest.

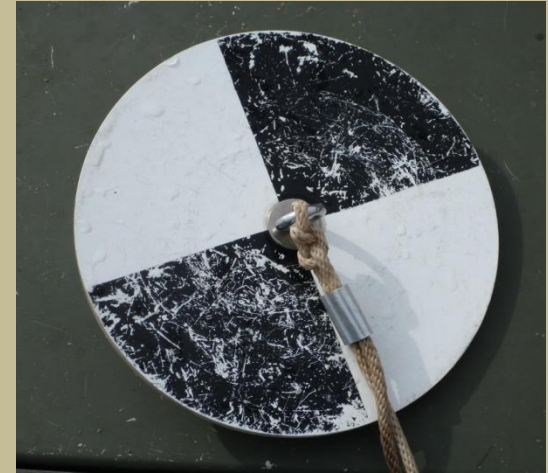

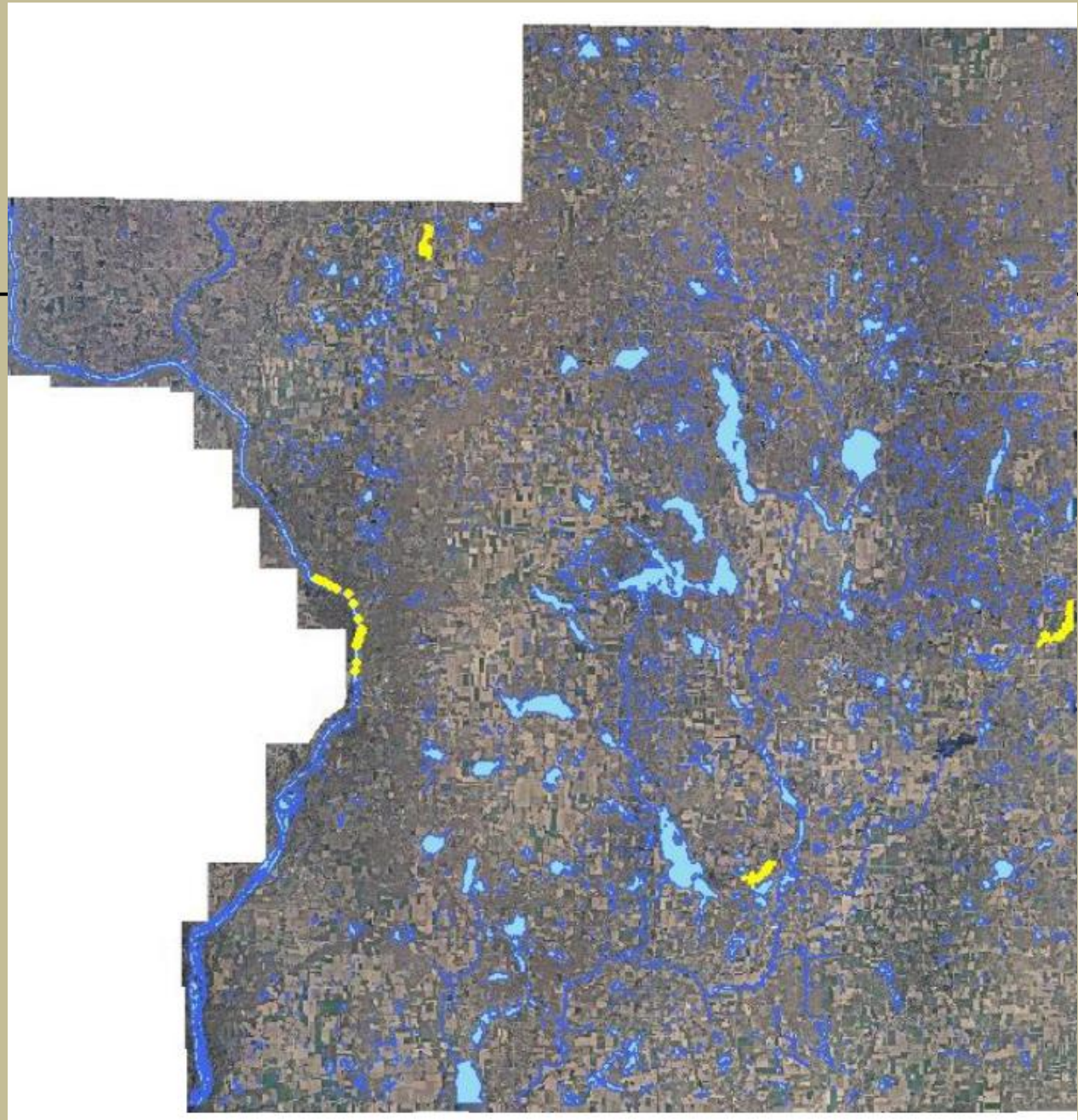

Eurasian Water-milfoil Distribution

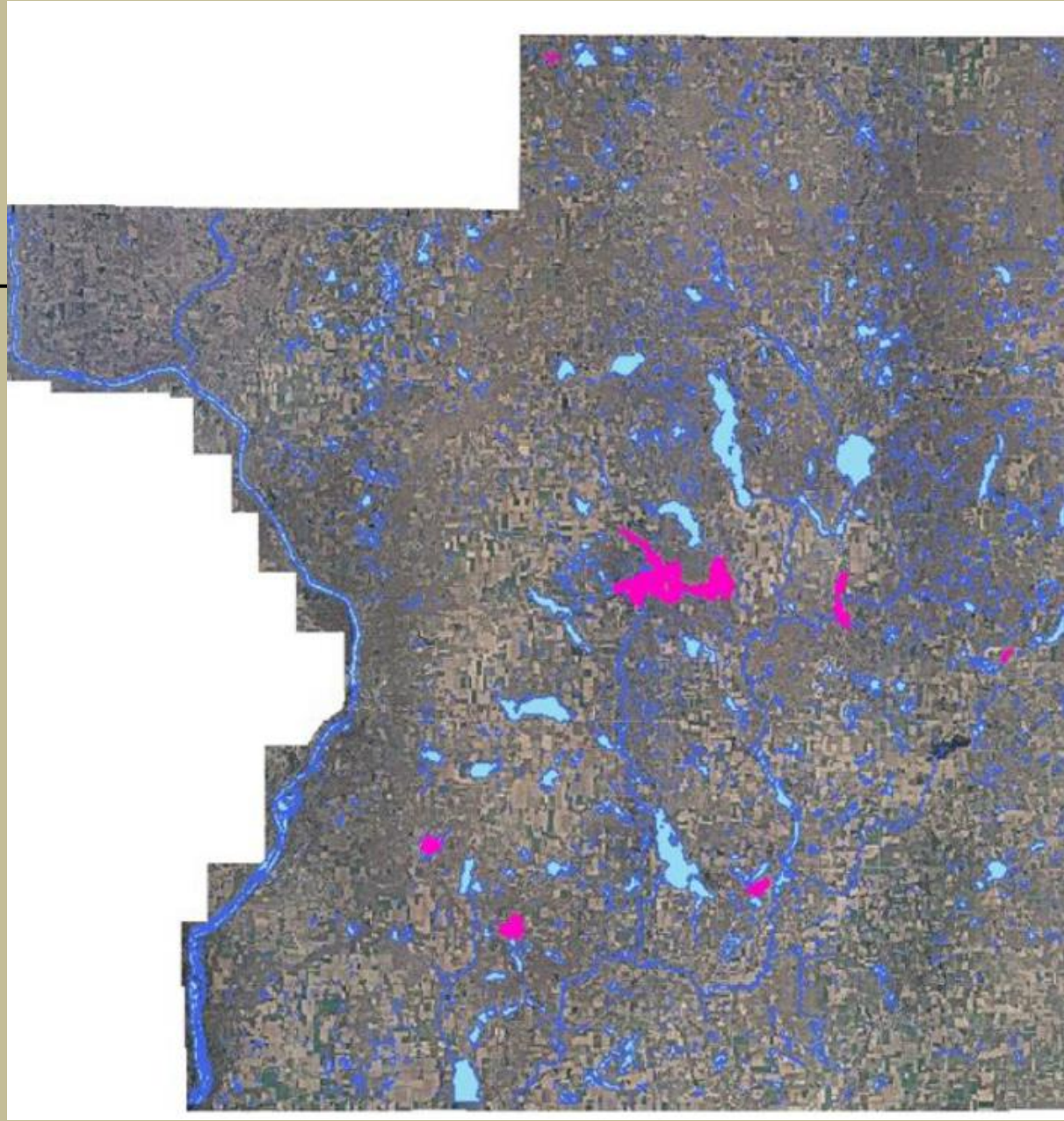

Purple Loosestrife Distribution

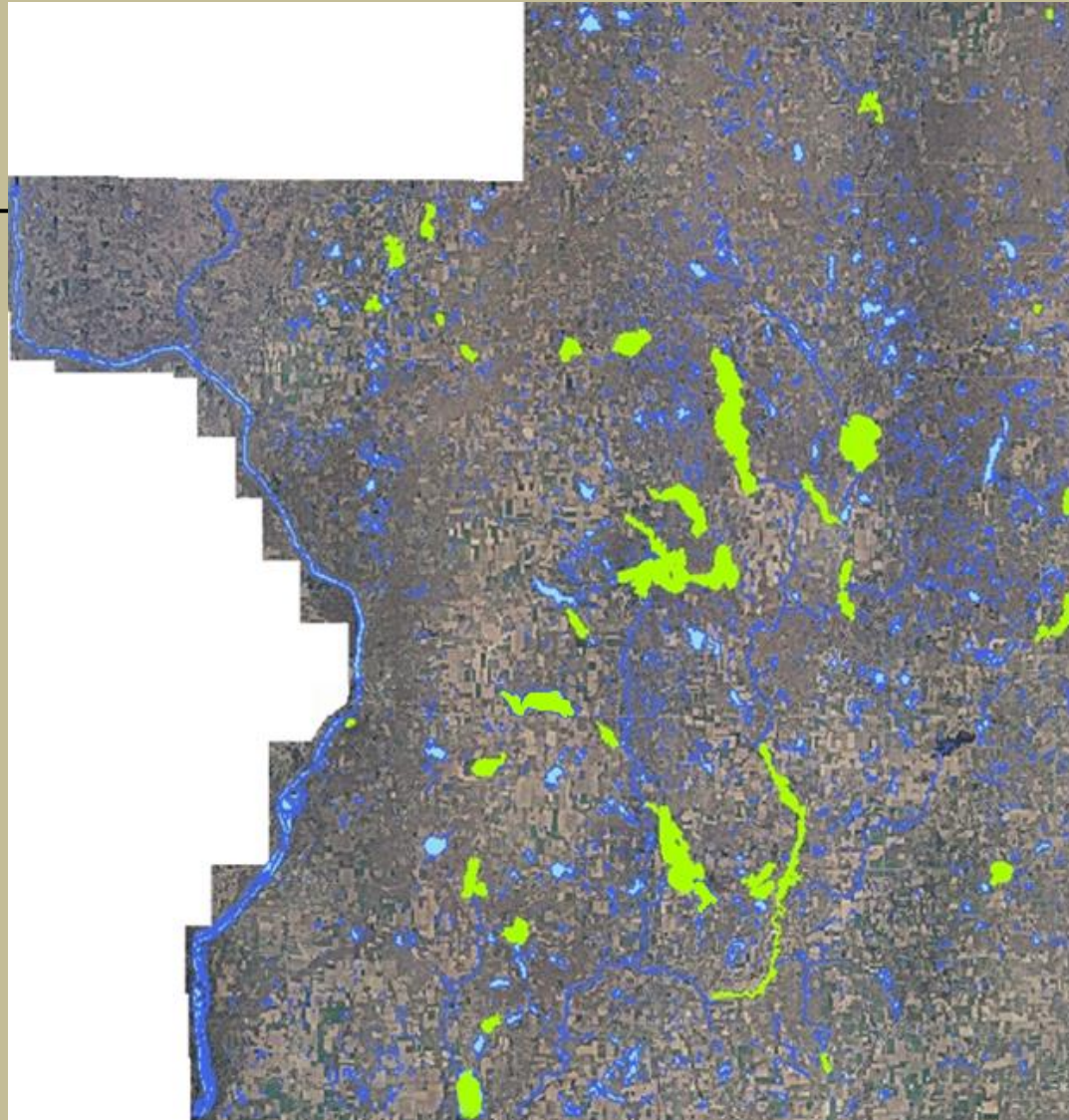

Slow No Wake Buoys



The No Wake zone on the Church Pine side of the channel will be extended further south into the main body of the lake. This will help reduce stirring of the sediment which in turn will reduce the need for future dredging of the channel. There will now be two No Wake buoys on Church Pine to mark the extended No Wake zone.



Boating Regulation *Reminders*



- **Slow, No Wake** speed means, a speed at which a vessel moves as slowly as possible while still maintaining steerage control.
- A No Wake zone extends out to 100 feet from any shoreline.
- A No Wake zone extends out 100 feet from any swimmer.
- PWC may not be operated faster than No Wake speed within 200 feet of the shoreline.

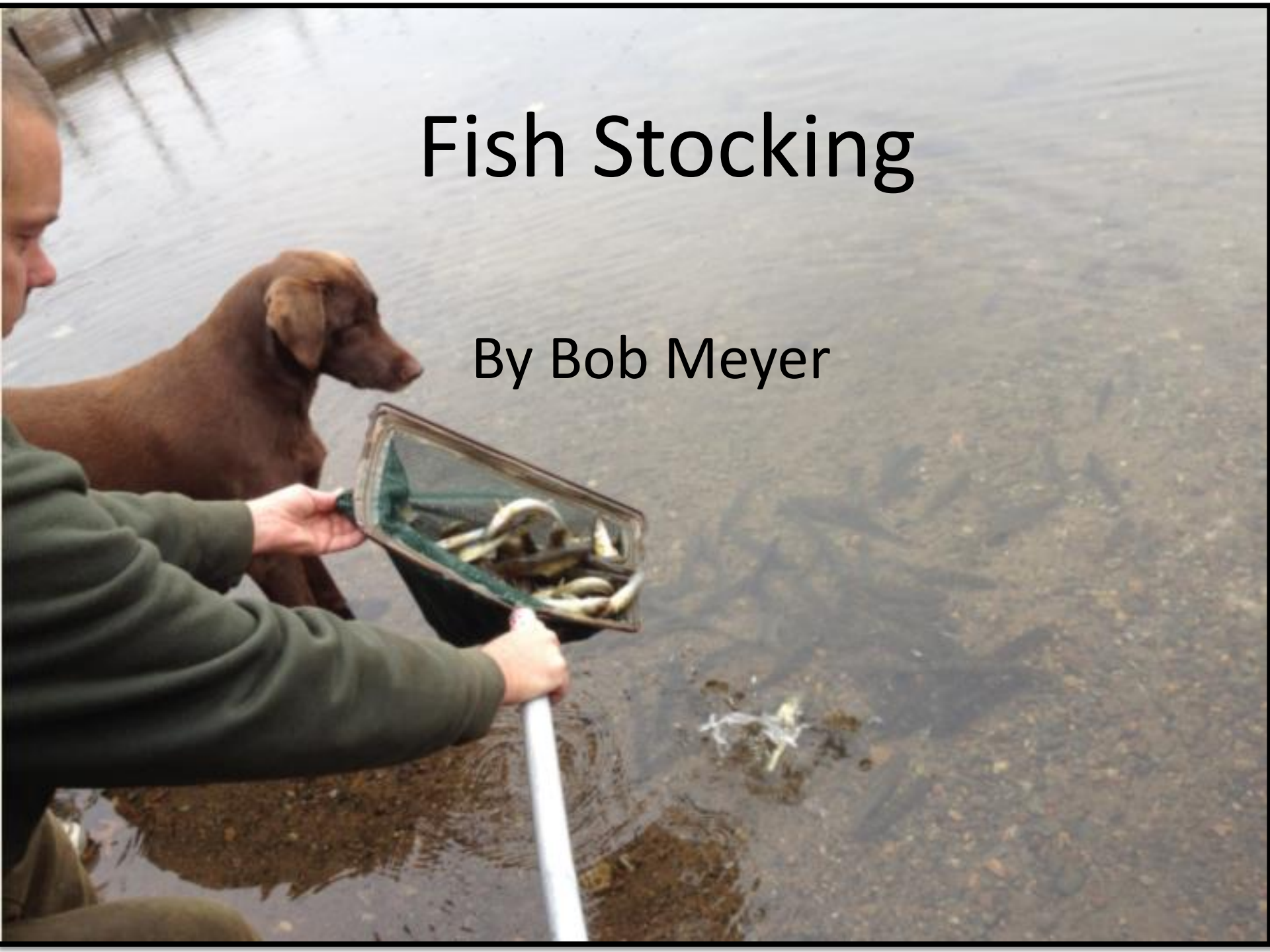
